## Executive Summary

On March 11, 2021, the American Rescue Plan Act (ARPA) was signed into law by the President. The intent of the legislation is to provide state, local and tribal governments with significant resources to respond to the COVID-19 public health emergency and its economic impacts. As part of this legislation, the City of Aurora received a total of \$65.4 million through ARPA's Coronavirus State and Local Fiscal Recovery Funds (SLFRF) to address issues exacerbated by COVID-19. The city plans to utilize funding to enhance services provided to residents impacted by COVID-19 and to fund a variety of transformational projects that will have a long-lasting impact on City of Aurora residents.

Through June 30, 2022, the City of Aurora has utilized funding of \$5,924,544 to provide a variety of programs to support the community and city services that were affected by the pandemic and its negative economic impacts. Uses of funds include programs to address affordable housing and homeless services, family assistance, mental/behavioral health support, assistance to non-profits, small business recovery, support for public safety and other essential workers, and restoring city services to pre-COVID levels, among other priorities.

In the fall of 2021, the city undertook a comprehensive process to identify projects to be funded with its ARPA SLFRF allocation. Internally, city department submitted potential projects based on a review of their internal needs.

In addition, the city embarked on a comprehensive public outreach campaign to obtain information from residents enabling the city to obtain feedback from a significant portion of the community which helped ensure the process of selecting projects was equitable.

A key engagement strategy utilized was developing and publishing a survey for the community to complete. That survey results indicated the community was interested in community assistance programs and was concerned about preserving the level of city services.

Based on internal and external information received, staff developed a formal recommendation for City Council to review. The city established a committee to review and score submitted projects. Staff considered multiple criteria when scoring projects including:

- Will the project benefit historically underserved, marginalized, or adversely affected groups?
- Is there a long-term return on the investment based on social outcomes, improved service quality or financial return?
- Are the benefits/impacts of the project identified as being high priority during the community engagement process?

The projects outlined on the following pages have commenced although many are still in the start-up phase.

*The intent of the use of funds was to promote the vaccination site in order to vaccinate residents, thereby reducing the spread of the COVID-19 disease.
