

TOWN OF BROOKHAVEN Recovery Plan

State and Local Fiscal Recovery Funds

August 31, 2021

Executive Summary

On May 10, 2021, the U.S. Department of the Treasury announced the launch of the Coronavirus State and Local Fiscal Recovery Funds (SLFRF), or Fiscal Recovery Funds, established by the American Rescue Plan Act of 2021 (ARPA) to provide \$350 billion in emergency funding for eligible state, local, territorial, and Tribal governments.¹

The State and Local Fiscal Recovery Funds is designed to deliver \$55 million to the Town of Brookhaven, in two tranches, one year apart, of \$27.5 million each, to support the immediate pandemic response, bring back jobs and lay the groundwork for a strong and equitable recovery. The Town received its first \$27.5 million allocation on June 1, 2021.

The Town of Brookhaven is a Township in the State of New York. Under Town governments in New York State, secondary education systems are independent self-taxing districts, and the Town has no jurisdiction over them. The same is true for Fire Districts.

County governments in the State of New York are responsible for all Health and Human Services, Social Services, including Adult and Youth support, Police Protection, and Emergency Services. As such, the Town of Brookhaven is limited in the programs it can sponsor directly to the community.

The U.S. Treasury Department has not yet issued its "Final Rule", after the public comment period ended on July 17, 2021. Currently the Town must rely upon U.S. Treasury's Interim Final Rule, the Treasury's "FAQs" updated on July 19, 2021, and the Compliance Reporting Guidance issued on June 24, 2021 to determine eligible projects and spending.

The Brookhaven Town Board has developed a Preliminary Recovery Plan within the above constraints in the hope that it will provide a framework for a strong and equitable recovery for all town residents. The Town has identified spending for only the first half allocation at this time. The Town Board has adopted 47 specific projects and budgets to be funded by the SLFRF Fiscal Recovery Funds, totaling \$27.2 million, of which \$10.36 million has been "Obligated", and \$1.36 million for actual expenditures.

Use of Funds

Coronavirus State and Local Recovery Funds provide the eligible state, local, territorial, and Tribal governments with a substantial infusion of resources to meet pandemic response needs and rebuild a stronger, more equitable economy as the county recovers. Within the categories of eligible uses, recipients have broad flexibility to decide how best to use this funding to meet the needs of their communities.

The Brookhaven Town Board has focused on the following Expenditure Categories as part of the first allocation of \$27.5 million:

- 1. Public Health
- 2. Negative Economic Impacts
- 3. Services to Disproportionately Impacted Communities
- 4. Premium Pay
- 5. Water, Sewer, Broadband Infrastructure
- 6. Revenue Replacement
- 7. Administrative and Other

All project allocations were made via a Resolution and have been unanimously approved by the Brookhaven Town Board (see Attachment A for complete set of resolutions approved to date).

Public Health

Local (Town) government provide residents with an array of critical services including, but not limited to, building permitting & inspection, roadway maintenance & traffic safety control, sanitation services, and maintaining of vital statistics (birth and death certificates). The continuity of local government is critical to a geographic area's health, safety, and economic prosperity.

Brookhaven Town Hall is the hub of local government housing 24 departments / divisions, over 300 employees, and hosts thousands of visitors each year. To ensure the health and safety of the employees and visitors the Town plans to use American Rescue Plan Act (ARPA) Fiscal Recovery Funds to provide:

- Employee Testing
- Employee Contact Tracing
- Personal Protective Equipment
- Expansion of the Town Call Center to meet social distancing guidelines (not yet adopted)
- Upgrade to the Town Hall Building Management System (to improve air circulation and air exchange)
- Replacement of Town Hall Air Handler (provide improved air filtration)
- Installation of Town Records Center Building Management System

Five (5) projects have been adopted by the Town, totaling \$2.1 million.

Negative Economic Impacts / Services to Disproportionately Impacted Communities

Although the pandemic's impacts have been widespread, both the public health and economic impacts of the pandemic have fallen most severely on communities and populations disadvantaged before it began. Low-income communities, people of color and tribal communities have faced higher rates of infection, hospitalization, and death.²

The U.S Treasury's Interim Final Rule identifies certain types of services that are eligible uses when provided in a Qualified Census Tract (QCT). These programs and services include those designed to build

stronger neighborhoods. Investments in parks, public plazas and other outdoor recreation spaces may be responsive to the needs of disproportionately impacted communities by promoting healthier living environments and outdoor recreation and socialization to mitigate the spread of COVID-19.³

The Town of Brookhaven like many governments saw a significant increase in the usage of Parks during the pandemic. The Town has identified seven locations that it has allocated ARPA Fiscal Recovery Funds to improve certain Parks in the community, for a total of \$835,000, of which five are within QCT and / or an LMI areas. The Town continues to assess its Parks system and how additional ARPA Fiscal Recovery Funds may be utilized to further enhance outdoor recreational opportunities particularly within QCT and / or LMI areas.

Summer Youth Employment Programs directly address the negative economic impacts of the pandemic on young people and their families and communities.⁴ The Town's Parks Departments employs more than 250 youth, at an annual cost of approximately \$40,000, in support of its summer programs which include camps, sports recreation programs, and staffing our pools, marinas and beaches. Residents throughout the Town are employed, and all are eligible to utilize these facilities and programs, including those in QCTs and / or LMI areas.

In addition, the Town has been committed to the Rehiring of employees who were either laid off, retired, or resigned. The Town has restored 12 full-time positions that were laid off in 2020 and replaced 19 full-time positions vacated since March 3, 2021. The Town plans to rehire an additional 29 full-time positions in the future. In addition, approximately 40 part-time positions have been Rehired since March 3, 2021. The total use of ARPA Fiscal Recovery Funds for Rehires is \$2.33 million in 2021, with a full year impact of \$6.4 million in 2022.

<u>Premium Pay</u>

The Town has not yet allocated any ARPA Fiscal Recovery Funds to the Premium Pay Category but may do so in the future.

Water, Sewer and Broadband Infrastructure

The Interim Final Rule generally aligns eligible uses of the ARPA Fiscal Recovery Funds with a wide range of categories of projects that would be eligible to receive financial assistance through the Environmental Protection Agency's Clean Water State Revolving Fund (CWSRF) or the Drinking Water State Revolving Fund (DWSRF). Consistent with the guidance, the Town has identified several infrastructure projects.

Water

The Town plans to enter in a Clean Water Partnership with Suffolk County Water Authority and will allocate approximately \$2.0 million of ARPA Fiscal Recovery Funds to provide public water to 116 parcels in the hamlet of Manorville, comprised of residential dwellings who currently receive drinking water from private wells. Contamination has been detected in some of these wells that exceed safe drinking water standards. The Town of Brookhaven and the Suffolk County Water Authority, seek to connect this community to safe, tested public drinking water through this initiative.

The Town also has identified seventeen (17) Stormwater / Clean Water Improvement Projects totaling \$9.1 million, particularly along the southern portion of the Town, designed to improve the water quality of the Great South Bay and other water bodies. All stormwater mitigation projects funded through the ARPA Fiscal Recovery Funds are designed to meet or exceed design criteria established by the New York State Stormwater Management Design Manual; and create resilient communities with improved water quality. The SLFRF Projects are designed to address climate change factors and mitigate non-point source pollutant inputs to surface waters, including embayments and tributaries to the Long Island Sound and the South Shore Estuary Reserve.

These Project designs include mitigation measures that improve natural infiltration, create bioretention systems, filter pollutants through mechanical proprietary structures, and protect vulnerable shoreline infrastructure and property. Pollutant load reduction calculations will be calculated for all project components that reduce sedimentation and/or nutrient inputs through the implementation of best management practices. Also, it is expected that Best Management Practices (BMP) and engineered solutions which include products such as Stormceptor® and / or Vortech® should enable the Town to achieve an 80 percent reduction of total suspended solids (TSS) load.

Each of the SLFRF Stormwater Projects also qualify under the Environmental Protection Agency's Clean Water State Revolving Fund (CWSRF) or the Drinking Water State Revolving Fund (DWSRF) and will be subject to the required qualitative water testing to ensure pollutants have been reduced.

<u>Sewer</u>

Three critical Sewer Infrastructure Improvement Projects have been allocated, totaling approximately \$4.0 million:

- **Brookhaven Town Hall** the existing wastewater treatment plant is approximately 40 years old. Despite best efforts, the age of the facility has led to periodic mechanical failures which have resulted in exceedances of permit limits for both TSS and BOD. The Town proposes a \$2.75 million upgrade by designing and installing an 8,000 gpd MLE treatment facility.
- Sewer District No. 2 the facility serves an industrial subdivision of approximately 235 acres with some 43 individual parcels and has a design flow of 200,000 gallons per day. Over 1,500 employees work at the industrial subdivision. The planned improvements include tank covers and an enhanced odor control system that will help prevent the evasive odors from the plant from adversely affecting the residential neighbors located to the south of this subdivision. These improvements will also improve the environmental conditions within the plant.

• Sandspit Marina - Sanitary System for one of the Town's South Shore Marinas, that also serves as a Fire Island Ferry Dock. The existing system requires replacement as it is antiquated traditional cesspool system located within 75 feet of the surface water.

Broadband

The Town of Brookhaven's primary Broadband provider, Altice USA, the provider of Optimum and Suddenlink internet, television, and phone service for the vast majority of residents, is developing a plan to deliver services to underserved communities, and the Town will develop its projects and ARPA Fiscal Recovery Funds the Altice final plans are completed.

As a start, Altice USA, is providing residential customers who meet the income eligibility criteria based on the FCC's rules will receive a monthly credit of up to \$50 towards their internet service and associated internet rental charges. See Attachment B for additional information.

Revenue Replacement

The Town's fiscal year is a calendar year, January 1st to December 31st. The Town has calculated its Revenue Loss to be \$17.0 million between fiscal years 2019 and 2020, based upon the Town's 2019 and 2020 Audited Financial Statements. The Town utilized the U.S Treasury Template, and followed all guidance in the Interim Final Rule and the Treasury's Frequently Asked Questions (FAQ's) as of July 19, 2021, including the Appendix regarding eligible Revenues to include and exclude in the calculation.

Sections 602(c)(1)(C) and 603(c)(1)(C) of the American Rescue Plan Act provide recipients with broad latitude to use the Fiscal Recovery Funds for provisions of government service, as defined under the Census Bureau's concept of "General Revenue from Own Sources" in the Annual Survey of State and Local Government Finances. Government services can include, but are not limited to, maintenance or pay-go funded building of infrastructure including roads; modernization of cybersecurity (including hardware, software, and protection to critical infrastructure); health services; environmental remediation; school or educational services; and the provision of police; fire and other public safety services.⁵

As indicated in the Executive Summary, policing, health services and social services fall under the jurisdiction of Suffolk County. Likewise, almost all fire protection and all educational services fall under self-taxing (non-Town) districts. Therefore, the Town's focus in the application of pay-as-you-go funding for the 2019 – 2020 Revenue Loss allocation is to support critical infrastructure in roads and sidewalks, and to enhance cybersecurity for critical Town technology.

The Town of Brookhaven has over 3,500 lane miles to maintain, and has an existing road resurfacing program; however, fiscal constraints in part due to the COVID-19 public health emergency have negatively impacted this program. The Town has identified ten (10) road and ADA sidewalk infrastructure projects to be funded from the 2019 – 2020 Revenue Loss allocation for a total of \$5.7 million.

To promote equitable outcomes, the Town has opted to apply the vast majority of its "2019 – 2020 Revenue Replacement" allocation towards Road Resurfacing and ADA Sidewalks, with seven of the ten projects in QCT and / or low-to-moderate (LMI) census tracts, or \$4.6 million.

In addition, the Town has identified one initial "Cybersecurity Project" as part of its initiative to migrate the Town's Data Center in Town Hall to the Microsoft Azure Government Cloud, for \$415,000.

Administrative and Other

The Town has not yet allocated any ARPA Fiscal Recovery Funds to the Administrative and Other Category but may do so in the future.

Promoting Equitable Outcomes

The Town of Brookhaven recognizes the negative economic impact of the COVID-19 public health emergency. In assessing the impact of the COVID-19 public health emergency and how best to utilize the Coronavirus State and Local Fiscal Recovery Funds (CLFRF) the Town Board sought to direct much of its actions towards certain communities and populations by focusing on areas of low-to-moderate income (LMI).

The United State Department of Housing and Urban Development (HUD) uses special tabulations of Census data to determine areas where at least 51% of households have incomes at or below 80% of the area medium income (AMI). Brookhaven Town utilizes the Uncapped Low-Moderate Summary Data as published annually by HUD.

Investment in disproportionately impacted communities by improving parks, roadways and outdoor spaces promotes healthier living, outdoor recreation, and socialization to mitigate the spread of COVID-19.

As of July 31, 2021, 21.1% of the ARPA Fiscal Recovery Fund's first half allocation of \$27.5 million has been directed by the Town Board to directly benefit QCT and / or LMI areas. Many of the other projects are town-wide and will benefit these areas as well.

In addition to ARPA Fiscal Recovery Funds, the Town of Brookhaven has received several Housing & Urban Development (HUD) grants to assist residents in Low-to-Moderate Income (LMI) areas of the Town who have been disproportionately impacted by the Coronavirus. The Town was awarded over \$2.5 million dollars in CARES Act Community Development Block Grant funds through the Department of Housing and Urban Development and is working with a local not for profit to assist in a CDBG-CV rental and mortgage arrears program. Furthermore, the Town was allocated \$3.3 million dollars from the American Rescue Plan for affordable housing through the HOME Investment Partnership Program. An additional \$3.0 million dollars in CARES Act funding was allocated through the Emergency Solutions Grant to prevent homelessness. These funds will assist the extremely low to medium income individuals/families.

Also, the Town was allocated just under \$29.0 million dollars from the U.S. Department of the Treasury for the Emergency Rental Assistance Program (ERA1 and ERA2), and redirected those monies to the New York State Office of Temporary Disability Assistance to administer the program.

Community Engagement

On January 22, 2002, the citizens of the Town of Brookhaven approved a referendum establishing ward (council) districts for the election of Town Board Members. The establishment of six Councilmanic Districts within the Town provide for improved communications and engagement by the Councilmembers and their respective constituents. Each of the six Councilmembers have active social media platforms and routinely engage their residents on a wide variety of town related issues. In addition, the council districts issue periodic electronic and physical newsletters advising their constituents of issues that may be of concern or interest. Residents can subscribe via email and/or text message to get news/events related to specific council districts and/or news/events related to specific topics, such as Highway and Traffic Safety. The Town of Brookhaven also has topic-specific Facebook pages, such as Youth Services, Parks and Recreation, Women's Services, Recycling, and the Animal Shelter. Furthermore, Brookhaven uses a wide variety of other social platforms, such as Instagram, Twitter, and YouTube.

In addition, the Town of Brookhaven maintains an interactive, ADA compliant website: (www.BrookhavenNY.gov) which, among other things, provides our residents with the Town Board Calendar as well as the Resolution Agenda for all Public Meetings. All Town Board Meetings are advertised on the Town website and in local newspapers and, residents are afforded an opportunity to speak before the Town Board at the start of each meeting on any upcoming Resolution or subject matter of their choice.

All meetings are live streamed in high definition through the Town's website and accessible thereafter on the website's "video on-demand" feature. Town meeting videos are indexed so residents can click on a section of the agenda, such as a public hearing or resolution, and jump right to that section of the video. This feature is especially helpful with our longer meetings, like Zoning Board, which can sometimes last several hours long.

The Town of Brookhaven has dozens of active community-based civic associations. Each civic association, as well as other interested parties, are e-mailed a copy of the resolution agenda in advance of the Town Board Meeting. The Town Supervisor also holds regular Business Recovery Task Force meetings with various Town staff to meet with community leaders, chambers of commerce and civics to discuss current

issues and provide assistance. A list of the participants and the meeting agendas can be found in Attachment C.

All allocations of the ARPA Fiscal Recovery Funds by the Town are made pursuant to Town Board Resolution. All resolutions, public hearings, and public notices are posted on the Town's website prior to the meeting and are accessible thereafter at www.BrookhavenNY.gov/Meeting. In addition, all Town Board meetings are broadcasted on a dedicated Government and Education cable television channel, with multiple viewing times.

Additionally, a presentation (report) to the Town Board was made at the August 26, 2021 Town Board Meeting which was open to the public and made viewable on the Town's website, and re-broadcasted on the dedicated Government and Education cable television channel.

Labor Practices

Section 135 of the New York State Finance Law, commonly known as the "Wicks Law," requires the Town of Brookhaven to bid specific separate Multiple Prime Contractors for certain public works (infrastructure) projects where the cost of the public work exceeds \$1.5 million. The Wicks Law requires that contract documents be subdivided into the following major Prime Contracts to permit separate and independent bidding and award:

- Construction
- Heating, Ventilation and Air Conditioning (HVAC)
- Plumbing
- Electrical

In additional, pursuant to New York State Labor Law, the Town of Brookhaven requires contractors and subcontractors to pay Prevailing Rate of Wage and supplements (fringe benefits) to all workers under a Public Works contract. Prevailing Wage is the pay rate (including fringe benefits) set by New York State law for work on public work projects, and in most cases complies with the Davis-Bacon Act. Employers must pay the Prevailing Wage Rate set for the locality where the work is performed. This applies to all laborers, workers or mechanics employed under a public work contract. The New York State Bureau of Public Work administers Articles 8 and 9 of the New York State Labor Laws:

Article 8 covers public construction

Article 9 covers building service contracts

Wage schedules are issued on a county-by-county basis (Brookhaven is in Suffolk County). The schedules contain the pay rates for each work classification. Under New York State law, all contracts between a government entity and a contractor must contain these schedules. Additional details, from the Town's boilerplate specification, can be found in Attachment D.

Beyond the New York State requirements, the Town of Brookhaven adopted a Town-wide policy in 2004 to require contractors and subcontractors (updated 2015) on Town-sponsored public works contracts to have an approved Apprenticeship Training Program (ATP). ATPs help to develop a skilled, properly trained and educated workforce. In the Town of Brookhaven, ATP is required for public works projects more than \$100,000. (See Attachment E) for Town Board Resolutions 2004-013 and 2015-674 for additional details). Additional details, from the Town's boilerplate specification, pertaining to the Apprenticeship Training Program can be found in Attachment F.

Furthermore, in 2019, pursuant to Resolution 2019-802 (See Attachment G) the Town Board established a Labor Advisory Committee. The Committee, consisting of several representatives from local trade unions, provides information and recommendations to assist the Town on labor related matters.

Public Works / Improvement Projects, including those to be financed via the Coronavirus State and Local Recovery Funds (CLFRF) are subject to the New York State and Town of Brookhaven requirements as outlined above.

To encourage local hiring, all Public Works projects are advertised on the Town's website and in local newspapers. In addition, the Town's Purchasing Division maintains a large database of contractors who are notified via e-mail when bids are advertised.

Use of Evidence

Wherever feasible, the Town will seek to apply evidence-based data to demonstrate outcomes and may engage an expert consulting firm to assist if needed.

Once such example is application of the NYSDEC Pollution Load Reduction Estimate Report (See Attachment H) which seeks to assess the effectiveness of the Non-point Source (NPS) Program and Best Management Practices (BMP) of the Town's proposed stormwater capital improvement projects. The assessment will be based on estimates of pollutant load reductions achieved by the projects with an emphasis on sediment, phosphorous and nitrogen.

Other examples include the Town's ability to measure Air Quality in Town Hall and the Records Center, related to the HVAC improvement projects under Public Health, and Water Quality Testing for the Contaminated Drinking Water Project.

WHEREAS, the Town's Apprenticeship Training Program requirements need to be strengthened and updated to ensure that the public policy goals underlying apprenticeship program requirements are satisfied.

NOW, THEREFORE, BE IT RESOLVED by the Town Board of the Town of Brookhaven that pursuant to Town Board Resolution No. 13, adopted April 8, 2004, be amended as set forth in the attached "Rules and Regulations for Implementation of Apprenticeship Training Program Requirements"; and be it further RESOLVED, that the Town Attorney together with the Director of

WHEREAS, the New York State Labor Law has been amended by the addition of Section 816-b, which authorizes governmental entities to require contractors and subcontractors to have apprenticeship agreements, approved by the New York State Commissioner of Labor, before entering into a construction contract with the entity; and

WHEREAS, the purpose of the law is to encourage labor and industry to participate in apprenticeship training programs so that the work force can meet the ever increasing need for skilled tradespeople; and

WHEREAS, the New York State Legislature adopted Article 23 of the New York Labor Law in 1961 to authorize the State Commissioner of Labor to develop standards for apprenticeship training and a process for certifying programs which meet said standards; and

WHEREAS, the promotion of apprenticeship training programs will expand the pool of skilled workers in the Town of Brookhaven by providing many residents the means to earn a decent living thereby fostering the local and regional economies;

NOW, THEREFORE, BE IT RESOLVED that the Town Board of the Town of Brookhaven hereby establishes a policy to promote apprenticeship training as authorized by Section 816-b of the New York Labor Law; and be it further

RESOLVED that "construction contract" shall mean any contract to which the Town of Brookhaven shall be a signatory which involves the construction, reconstruction, improvement, rehabilitation, installation, alteration, renovation, demolition or otherwise providing for any building, facility or physical structure of any kinds with a value in excess of \$250,000; and be it further

RESOLVED that the "contractor or subcontractor" shall mean a contractor or subcontractor which directly employs labor under a construction contract for which an apprenticeship program has been approved by the New York State Commissioner of Labor in accordance with Article 23 of the New York Labor Law; and be it further

RESOLVED that the Town Board of the Town of Brookhaven hereby requires any contractor or subcontractor, prior to entering into a construction contract with the Town of Brookhaven, to have apprenticeship agreements, appropriate for the type and scope of work to be performed, which have been registered with, and approved by, the New York State Commissioner of Labor in accordance with Article 23 of the New York Labor Law anything in Section 103 of the New York General Municipal Law to the contrary notwithstanding; and be it further

RESOLVED that this Resolution shall apply to construction contracts advertised for bids on or after the effective date; and be it further

RESOLVED, that this Resolution shall not apply to professional services, engineering services, custodial services, maintenance services, equipment purchases or federally funded programs; and be it further

RESOLVED that the Town Attorney, together with the Director of Purchasing, are hereby authorized, empowered and directed to promulgate such rules and regulations

RULES AND REGULATIONS FOR IMPLEMENTATION OF APPRENTICESHIP TRAINING PROGRAMS

AUTHORITY

- Article 23 Sec. 816b of the New York State Labor Law.
- Town Board Resolution adopted April 8, 2004, to Require Apprenticeship Training Programs for Town contracts.

DEFINITIONS

- Apprenticeship Training Program A program registered with and approved by the New York State Commissioner of Labor.
- Construction Contract Any contract to which the Town of Brookhaven shall be a signatory which involves the construction, reconstruction, improvement, rehabilitation, installation, alteration, renovation, demolition or otherwise providing for any building, facility or physical structure of any kind which also includes, but is not necessarily limited to, highways and associated appurtenances, bridges, bulkheads and docks.
- Contractor or Subcontractor A Contractor which directly employs labor under a construction contract for which an apprenticeship program has been approved by the NYS Commissioner of Labor in accordance with Article 23 of the NYS Labor Law.
- Work Permit Work permits are issued by the Highway Superintendent to a
 person, firm, corporation or municipality for the purpose of performing work
 on Town owned infrastructure associated with non-Town development,
 maintaining and/or installing wires, conduit, drainage, sewer and water
 pipes and associates appurtenances.
- Maintenance Shall be the work that keeps the Town infrastructure in proper condition including, but not limited to, pavement patching and crack sealing and building roofing repairs are items of work in this category.

APPLICABILITY

These regulations are applicable to any construction contract for an amount in excess of \$250,000 and up to \$3,000,000.

GENERAL REQUIREMENTS (ANNUAL ON CALL) CONTRACTS THAT ARE NOT CONSIDERED MAINTENANCE

Multiple prime contracts – where multiple prime contracts are required by law, the aggregate cost of the individual contracts, for the term of each, shall be utilized in determining applicability.

Single prime contracts - applicability shall be based on the aggregate cost of all work progressed during the term of the contract.

PROJECT SPECIFIC CONTRACTS

Multiple prime contracts – where the aggregate cost of the individual contracts for a specific project is in excess of \$250,000 and up to \$3,000,000, contracts will only be awarded to firms which have appropriate apprenticeship training programs. The applicability of the Project Labor Agreement will be evaluated for projects where the aggregate cost of the contracts is anticipated to exceed \$3,000,000.

Single Prime Contracts – Applies to construction contracts in excess of \$250,000 and up to \$3,000,000. The applicability of the Project Labor Agreement will be evaluated for projects where the aggregate cost of the contracts is anticipated to exceed \$3,000,000.

These regulations are NOT applicable to projects involving maintenance, custodial services, any work or contracts involving leased facilities, highway and sanitation construction performed pursuant to Work Permits issued by the Town of Brookhaven, engineering/architectural services, equipment purchases and federally funded projects.

If a specific trade does not have a NYS Department of Labor approved Apprenticeship Training Program at the time of the award of a contract, these regulations do not apply for that trade.

COMPLIANCE TIME FRAME

Within ten (10) working days of the date of receipt of notification from the Town of the Contractor's status as the apparent lowest responsible bidder, unless an extension of time is granted by the Town, the Contractor is required to submit an affidavit of the firm's participation in registered and approved New York State Apprenticeship Training Program in accordance with these rules and regulations. If the Contractor does not comply within the specified time, the Town Attorney and the Director of Purchasing may declare the Contractor's bid proposal non-responsive and award the contract to the next responsible bidder.

Subcontractors are also required to provide evidence of participation in approved apprenticeship training programs. Each Subcontractor is to execute an affidavit of participation which is to be included with the Contractor's request to the Town for Subcontractor approval.

AWARD OF CONTRACT

OWNER'S RIGHT TO SUSPEND OR TERMINATE CONTRACT

If during the course of a contract, the Contractor or his/her Subcontractor is not in compliance with these regulations, the Town Attorney and the Director of Purchasing may then suspend the work and take whatever action is deemed appropriate as more specifically defined under "Owner's Right to Suspend or Terminate Contract" in the contract document.

- 1. If the amount bid for this Contract, or the cost of the individual contracts on multi-prime contracts that comprise the Project, is in excess of \$100,000 (cost of material and labor), the Contract(s) will be subject to Town's "Rules and Regulations for Implementation of Apprenticeship Training Program Requirements" (herein Town's Rules and Regulations), which requires that firms entering into Town contracts, as defined in the Town's Rules and Regulations, to participate in a registered and approved New York State Department of Labor Apprenticeship Training Program(s). In accordance with the Town's Rules and Regulations, the Contractor and any Subcontractors shall provide evidence of participation in a registered Apprenticeship Training Program(s) approved by New York State Department of Labor, that are applicable and appropriate for the type and scope of work to be performed under the Contract(s).
 - A. At the time of bid submission, the Contractor shall submit with its bid an affidavit and proof of participation in a registered and approved NYS Apprenticeship Training Program in accordance with the Town's Rules and Regulations. If the Contractor does not submit the required affidavit and proof of participation in an Apprenticeship Training Program, the Town may declare the Contractor's bid non-responsive and award the Contract to the next lowest responsible Bidder.
 - B. At the time of bid submission, the Contractor shall also submit to the Department of Purchasing and the Engineer, for approval, the names of all Subcontractors to be employed on the project, and an affidavit and proof of each Subcontractor's participation in an Apprenticeship Training Program in accordance with the Town's Rules and Regulations.
 - C. Upon the Contractor's written request and a showing of good cause the Department of General Services Designee in consultation with the Town Attorney may grant an extension, not to exceed ten business days from the bid opening date, for the Contractor to submit the required proof of the Contractor's and/or Subcontractor's participation in an Apprenticeship Training Program in accordance with the Town's Rules and Regulations. If the Contractor does not submit the required affidavit(s) and proof of participation, the Town may declare the Contractor's bid non-responsive and award the Contract to the next lowest responsible Bidder.

RULES AND REGULATIONS FOR IMPLEMENTATION OF APPRENTICESHIP TRAINING PROGRAM REQUIREMENTS

AUTHORITY

Article 23 Section 816-b of the New York State Labor Law; Town Board Resolution No. 13 adopted April 8, 2004, Requiring Apprenticeship Training Programs for Town contracts.

DEFINITIONS:

The following terms shall have the meanings as set forth herein:

- Apprentice A participant registered under a New York State Department of Labor registered Apprenticeship Training Program in accordance with Article 23 of the New York State Labor Law and 12 NYCRR §600, et seq., and any amendments thereto.
- Apprenticeship Training Program An Apprenticeship Training Program registered and approved by the Commissioner of the New York State Department of Labor pursuant to 12 NYCRR §600, et seq., and any amendments thereto.
- Construction Contract Any contract to which the Town of Brookhaven shall be a signatory which
 involves the construction, reconstruction, improvement, rehabilitation, installation, alteration,
 renovation, demolition or otherwise providing for any building, facility or physical structure of any
 kind, which also includes, but is not necessarily limited to, highways and associated appurtenances,
 bridges, bulkheads and docks.
- Contractor Any person, firm, or corporation or entity awarded a contract by the Town, which directly employs labor under a construction contract, as defined herein.
- Subcontractor Any person, firm, or corporation or entity having a direct contract with the Contractor or with any other Subcontractor for supplying labor at the Town work site.
- Work Permit Issued by the Highway Superintendent to a person, firm, corporation or municipality for the purpose of performing work on Town owned infrastructure associated with non-Town development, maintaining and/or installing wires, conduit, drainage, sewer and water pipes and associated appurtenances.
- Maintenance Work for keeping the Town infrastructure in proper condition including, but not limited to, pavement patching, crack sealing and building repairs are items of work in this category.
- Sponsor An employer, group of employers, or a joint apprenticeship committee (JAC) representing both employers and a union, which has the ability to train Apprentices, and which is recognized as such by the Department of Labor through the registration of a program (as defined pursuant to (12 NYCRR §601.3 and amendments thereto).

APPLICABILITY

The Town's "Rules and Regulations for Implementation of Apprenticeship Training Program Requirements" (herein Town's Rules and Regulations) shall apply to any awarded construction contract, as defined herein, in an amount in excess of \$100,000.00 (for cost of material and labor). The applicability of a Project Labor Agreement will be evaluated for projects where the aggregate cost of the contract(s) is anticipated to exceed \$3,000,000. If a Project Labor Agreement has been executed, the Contractor/Subcontractor shall demonstrate compliance with the Apprenticeship Training Program requirements as set forth herein.

During the term of the contract, the Contractor and/or Subcontractor shall be required to submit verification on a quarterly basis that Apprentices under a registered NYS Department of Labor Apprenticeship Training Program have worked on the specific Town project, work site, the subject of the Contract. Apprentices shall be employed in accordance with NYS Department of Labor ratios.

Projects that are funded by grant monies are subject to the policies and regulations of the Authority that provided the grant funds.

GENERAL REQUIREMENTS (ANNUAL ON CALL) CONTRACTS (OTHER THAN MAINTENANCE)

The Town's Rules and Regulations shall be applicable to any contract over \$100,000 (for labor and material) based on anticipated aggregate amount as provided in the Town Board's resolution for the award of the Contract. If the amount stated in the awarding resolution is under the \$100,000 threshold (for labor and material), the Contractor acknowledges and agrees that upon the cost of the contract work during the term of the contract exceeding the \$100,000 threshold the Contractor and/or Subcontractor shall be required to comply with the Town's Rules and Regulations promulgated herein.

PROJECT SPECIFIC CONTRACT

Multiple Prime Contracts: Where multiple prime contracts are required by law, (for example, General Municipal Law §101 -Wicks Law) the cost of the individual Contracts, for the term of each, shall be utilized in determining applicability. If the amount stated in the awarding resolution is under the \$100,000 threshold, the Contractor acknowledges and agrees that upon the cost of the contract work during the term of the Contract exceeding the \$100,000 threshold, the Contractor and/or Subcontractor shall be required to comply with the Town's Rules and Regulations promulgated herein.

Single Prime Contracts: Applicability shall be based on the anticipated aggregate cost of work as stated in the Town Board's resolution awarding the Contract. If the amount stated in the awarding resolution is under the \$100,000 threshold for material and labor, the Contractor acknowledges and agrees that upon the cost of the Contract work during the term of the contract exceeding the \$100,000 threshold the Contractor and/or Subcontractor shall be required to comply with the Town's Rules and Regulations.

These regulations are NOT applicable to projects involving maintenance, custodial services, any work or contracts involving leased facilities, highway and sanitation construction performed pursuant to Work Permits issued by the Town of Brookhaven, engineering/architectural services,

equipment purchases.

If a specific trade does not have a NYS Department of Labor registered approved Apprenticeship Training Program at the time of the award of the Contract, the Town's Rules and Regulations do not apply for that trade. However, if during the term of the Contract, the NYS Department of Labor approves that trade for registered apprenticeship purposes, the Contractor and/or Subcontractor shall comply with the Town's Rules and Regulations. Within thirty (30) days of notification from the Town that the New York State Department of Labor has approved that trade for registered apprenticeship purposes, the Contractor and/or Subcontractor shall submit proof of its participation in an Apprenticeship Training Program for that trade.

COMPLIANCE TIME FRAME

At the time of bid submission, the Contractor shall submit with its bid, proof of the Contractor's participation in an Apprenticeship Training Program in accordance with the Town's Rules and Regulations, as set forth herein. Each Contractor shall also submit an executed affidavit, under penalties of perjury, as to the firm's participation, which shall be submitted with proof of participation.

At the time of bid submission, the Contractor shall also submit with its bid, for the Town's approval, the names of all Subcontractors to be employed on the project, and proof of each Subcontractor's participation in an Apprenticeship Training Program in accordance with the Town's Rules and Regulations. Each Subcontractor shall also execute an affidavit of participation, under penalties of perjury, which shall be submitted with the Contractor's bid and request to the Town for Subcontractor approval.

Upon the Contractor's written request and a showing of good cause, the Department of General Services Designee in consultation with the Town Attorney may grant an extension, not to exceed ten business days from the bid opening date, for the Contractor to submit the required proof of the Contractor's and/or Subcontractor's participation in an Apprenticeship Training Program.

If the Contractor does not comply within the specified time the Department of General Services Designee in consultation with the Town Attorney shall declare the Contractor's bid proposal non-responsive and award the Contract to the next responsible bidder.

AWARD OF CONTRACT

Prior to the award of any contract, the Department of General Services Designee shall advise the Town Attorney and the Commissioner(s)/Department Head(s) that the apparent low bidder presented the required proof of participation in an Apprenticeship Training Program in accordance with the Town's Rules and Regulations.

No contract may be awarded unless the Contractor has demonstrated compliance with the Town's Rules and Regulations, set forth herein. Upon the Contractor demonstrating extraordinary circumstances beyond the Contractor's control and submitting written documentation of such extraordinary circumstances, the Town Attorney and the Department of General Services Designee in their sole discretion may grant additional time for the Contractor to submit proof of the required participation in an Apprenticeship Training Program.

Note: Extraordinary circumstances shall not include the Contractor's Subcontractor's pending applications for NYS Department of Labor registration and approval of Apprenticeship Training Program(s), unless a trade has not been previously approved by the New York State Department of Labor for apprenticeship purposes.

CONTRACT TERM

During the term of the Contract, the Contractor and Subcontractor(s) shall submit with the Contractor's invoice, proof of participation in accordance with the Town's Rules and Regulations, set forth herein.

PROOF OF PARTICIPATION IN AN APPRENTICESHIP TRAINING PROGRAM

The Contractor and Subcontractor(s) shall submit the following documentation demonstrating participation in an Apprenticeship Training Program:

- 1) Proof that the sponsor of the Apprenticeship Training Program received New York State Department of Labor approval.
- 2) The name of Apprentices employed on Town contract work under an Apprenticeship Training Program. The hours of training provided to the apprentices at Town work site.
- 3) The sponsor's documentation stating the number of the active, completed and terminated Apprentices that the Contractor and/or Subcontractor employed on prior and current Town contract work. (The sponsor's latest filing of its registered Apprenticeship Training Program as applicable to Town contracts.)
- 4) Journeyman's evaluation reports on Apprentices utilized by the Contractor and the Subcontractor(s) on Town contract work as maintained by the sponsor.
- 5) During the term of the contract, the Contractor and/or Subcontractor shall be required to submit verification on a quarterly basis that Apprentices under a registered NYS Department of Labor Apprenticeship Training Program have worked on the specific Town project, work site, the subject of the Contract. Apprentices shall be employed in accordance with NYS Department of Labor ratios.
- 6) Certified payroll records demonstrating journeyman were present on the Town work site in order to provide appropriate guidance to Apprentices registered in an Apprenticeship Training Program, during on-the-job training.
- 7) Documentation that the number of journeyman employed on Town contract work complied with New York State Department of Labor ratios for employment of Apprentices.
- 8) Records of the sponsor's recruitment, including the appropriate recruitment announcement and the resulting applicant list as may be applicable to Town of Brookhaven contracts.

Note: Subcontracting the work under the Contract to a firm that participates in an Apprenticeship Training Program shall not satisfy the Contractor's requirements under the Town's Rules and Regulations. The Contractor shall only subcontract the work for trades that the Contractor is not authorized or qualified to perform and is beyond the knowledge or expertise of the Contractor.

SUSPENSION OR TERMINATION OF CONTRACT

Failure to provide proof of participation in an Apprenticeship Training Program shall be deemed a violation of the Contract and grounds for immediate termination. If during the course of a Contract, the Contractor or any Subcontractor is not in compliance with the Town's Rules and Regulations, the Town Attorney with the Department of General Services Designee may then suspend work and take whatever action is deemed appropriate as more specifically defined under "Owner's Right to Stop Work or Terminate Contract" in the Contract document.

Failure to comply with the Town's Rules and Regulations during the Contract term, may result in the Contractor being determined a non-responsible bidder on future Town contracts.

POLLUTANT LOAD REDUCTION ESTIMATE REPORT

NYSDEC Water Quality Improvement Project program

The purpose of this report is to assess the effectiveness of the Nonpoint Source (NPS) Program and Best Management Practice (BMP) implementation projects in protecting waters of the state. The assessment will be based on estimates of pollutant load reductions achieved by a project, with emphasis on sediment, phosphorus and nitrogen. The report is also intended to support compliance with federal requirements for states to report estimates of pollutant load reductions accomplished by nonpoint source implementation projects.

Background

Best Management Practice (BMP) implementation projects intended to control sediments and/or nutrients (phosphorus and nitrogen) are required to provide estimates of the expected NPS pollutant load reductions. Estimates are to be provided in appropriate units (tons/year or pounds/year).

The New York State Department of Environmental Conservation (NYSDEC) does not require a specific methodology for developing estimates of NPS pollutant load reductions. Several existing models which have been used for this purpose are acceptable to NYSDEC, and other unlisted alternative methods may be used. However, NYSDEC does require that the method used to develop NPS pollutant load reductions be identified by the grantee. NYSDEC approval of alternative methodologies is <u>not</u> required, though such methods must be described.

Existing models which may be used by the grantee for estimating NPS pollutant load reductions are the Revised Universal Soil Loss Equation (RUSLE), and the EPA "Region 5 Model" (also referred to as STEPL, or the Spreadsheet Tool for Estimating Pollutant Load).

The Revised Universal Soil Loss Equation is described, with step-by-step instructions and examples, in the *New York State Standards and Specifications for Erosion and Sediment Control*, August 2005, in Appendix A. This manual is available at the following website (scroll through for Appendix A):

A narrative summary is requested for all projects. The narrative may be a qualitative description and may be used to provide an enhanced summary of a project's benefits. If quantitative estimates are included in the narrative, reporting annual rates or annual totals is recommended.

STEP 5 - Complete Information on Person(s) Developing Pollutant Load Reduction Estimates

This information is requested if any further clarification is needed.
