## EXECUTIVE SUMMARY

As of May 2022, Tulsa County has received \$124 million (\$124,063,773.35) through the American Rescue Plan (ARP). Since 2021, Tulsa County Officials have worked amongst elected officials, state and local leaders, non-profit organizations and others to allocate funds based on local and federal priorities. As of June 30, 2025, \$126,556,338.00 has been awarded to 127 separate projects and approximately \$89 million of those awards have been expended.

The Tulsa County Board of Commissioners approves all ARP expenditures during weekly public meetings. The Tulsa County ARP Committee is an advisory group that meets nearly every week to hear and discuss project proposals that adhere to ARP guidelines. The committee consists of the Chair of the Board of County Commissioners, two deputy county commissioners, the Tulsa County Clerk, the Tulsa County government affairs director and the Tulsa County procurement director. The committee often requests assistance from other staff including those involved with budget and accounting, legal, and communications.

The committee has hosted dozens of community leaders and evaluated many proposals to assess the overall needs for economic recovery and public health in Tulsa County. Representatives have also brought Tulsa County's approach to external community groups, including the Tulsa Regional Chamber board of directors, Tulsa Community Foundation funder roundtable, Tulsa Area United Way, Greenwood Chamber of Commerce, Visit Tulsa, tribal leaders, city leaders, area state representatives and senators, and more.

## **Tulsa County's Use of Funds**

Tulsa County's ARP Plan focuses on five priorities. The following are Tulsa County's top priorities.:

## **Respond to COVID-19**

As the acute phase of the COVID-19 pandemic concludes, Tulsa County is responding appropriately. Expenditures in this category include internally and externally focused projects. Internally, Tulsa County must ensure that its employees are able to operate critical functions and provide services to residents safely. Externally, Tulsa County continues to partner with community leaders in various industries and sectors to support public health.

Overall, this priority includes a broad approach to public health, including support of expanded mental and physical health services; support for organizations that provide necessities such as food and shelter. At the height of the pandemic, purchasing and dissemination of personal protective equipment; supporting access to testing, remote working assistance and more.

Several key datasets dominate this priority. Internally, Tulsa County tracked its COVID-19 rates among more than 1,000 employees to minimize exposure. Externally, Tulsa County has continued to work with with the Tulsa Health Department to monitor and respond to county-wide data trends. Countywide COVID-19 data can be found here:

# **Support Economic Recovery and Development**

Tulsa County supports recovery from the economic downturn that started in 2020 including economic development, tourism, workforce development and more.

Key metrics in the priority include long-standing local strategies combined with post-pandemic studies, including a Tulsa County CARES-funded study in 2020 that examined recovery needs. A significant recommendation focused on the need to upgrade workforce credentials, training and certifications across the region.

## Generate Equity in Underserved Populations & Communities

Most projects, regardless of their driving priority, include aspects that promote equity among underserved populations and communities. The return on the investment in the organizations who serve these populations will be realized long after the funds have been expended. This is a key component of ARP funding and an overarching priority for Tulsa County.

Tulsa County has shaped applicable projects to focus on improving equity among underserved populations and communities, including qualified census tracts (QCTs).

Additionally, surveys submitted by local partners, such as the Point in Time Count, conducted by Housing Solutions have identified areas where a targeted response is critically warranted. The Point in Time Count is a requirement of Continuum of Care by the U.S. Department of Housing and Urban Development. These metrics show a considerable need for affordable housing and wrap around services for one of Tulsa County's most vulnerable populations, the chronically homeless community."


The overall objective is to strategically invest in the longterm legacy of non-profits and their continuous outreach efforts to disproportionately impacted communities.

## **Build Infrastructure**

Tulsa County has identified infrastructure needs that meet the guidelines and objectives of ARP funding and the Bipartisan Infrastructure Plan.

## **Replace Lost Revenue**

Tulsa County departments, agencies and authorities were negatively impacted by the loss of millions in revenue due to the economic downturn created by the pandemic. ARP provides for lost revenue, which Tulsa County is tracking and will balance replacement revenue with emergency needs due to COVID-19 within the community. Tulsa County has identified a loss of revenue total of \$30,481,408.00.



## **Election Board Expansion**

#### **Beneficiary organization:**

Tulsa County/Tulsa County Election Board

Treasury expense category: 1.4 Approved amount: \$9,200,000

Actual payment through June 30: \$9,167,051.94

## **Project description:**

The Tulsa County Election Board expansion, led by the Election Board and Tulsa County Board of County Commissioners, requested \$9,200,000 to purchase a new building to allow social distancing for poll workers and voters in accordance with Treasury expense category 1.4 guidelines.

Increased storage needs due to a significant rise in absentee ballots during recent elections and the physical layout of the existing building impeded standard COVID-19 mitigation practices. A third-party evaluation has been completed and the purchase has been finalized. The independent assessment was conducted to ensure the project met Treasury guidelines and alternative COVID-19 mitigation methods were considered.

## Additional information provided by the recipient:

The Tulsa Health Department encouraged this project due to the conditions in the existing Tulsa County Election Board facility – a building that is ripe for the rapid spread of the virus, especially during election time frames. Tulsa Health Department Director Dr. Bruce Dart provided a letter in support of this expansion project stating, "Limited space, inadequate ventilation, high public contact, and mass gatherings are challenges which cannot be addressed in the current location of the Election Board. For this reason, it is in the public's health and safety interest that a new location for the operations of the Election Board be seriously undertaken in response to the public health emergency."

The Oklahoma State Auditor and Inspector's Office provided guidance on this project and was satisfied that the expansion met Treasury guidelines. In their words, "We believe this expenditure could be made under the Public Health category 1.4..."

## **OSU Medical Center Expansion**

## **Beneficiary organization:**

**OSU Medical Center** 

Treasury expense category: 1.12 Approved amount: \$4,000,000

Actual payment through June 30: \$4,000,000

## **Project description:**

The OSU Medical Center Expansion requested \$4 million to support a major expansion to its existing facility that focuses on services targeted towards military veterans and patients with mental health challenges. The OSU Medical Center serves a large portion of Tulsa's indigent population. Increasing veterans and mental health service capacity will support equitable outcomes throughout the community. OSU Medical Center anticipates an additional 100 residency and 30 clinical faculty positions will be created and 106 patient beds will be provided by the expansion. This project is under construction and has been made possible through a partnership of Tulsa County, philanthropic donations, and other municipalities such as the City of Tulsa. This project was funded in accordance with Treasury expense category 1.12 guidelines.

# **Tulsa Health Department Testing Reimbursement**

Actual payment through June 30: \$350,095

## **Project description:**

COVID-19 testing by the Tulsa Health Department was crucial to the response to the pandemic in Tulsa County. Health Department officials requested funds to provide testing supplies, labor, and facilities for high-volume testing. Tulsa County awarded \$500,000 to reimburse the Tulsa Health Department for these expenses provided for by Treasury expense category 1.2.

## Council Oak Comprehensive Healthcare Center Monoclonal Antibody Infusion Center Operations

Actual payment through June 30: \$500,000

## **Project description:**

Council Oak Comprehensive Healthcare Center monoclonal antibody infusion center operations, led by the Muscogee Nation Health Department, requested \$500,000 to support an operations expansion to open a monoclonal antibody infusion center to treat COVID-19 patients. This project was completed in accordance with Treasury expense category 1.6 guidelines.

# **Expo Facility Usage and Meals for Vaccination Drive**

Tulsa County Public Facilities Authority (Expo Square)

Treasury expense category: 1.1 Approved amount: \$374,598.88

Actual payment through June 30: \$374,598.88

#### **Project description:**

The Tulsa Area Emergency Management Agency in conjunction with the Tulsa Health Department utilized event space at Expo Square for months in support of vaccination programs and response to the COVID-19 pandemic. In total, \$374,598.88 was expended to support multiple vaccination programs over several months. These funds were awarded in accordance with Treasury expense category 1.1 guidelines.

# **Country Corner Emergency Vehicle**

## **Beneficiary organization:**

Country Corner Fire District Inc. **Treasury expense category:** 1.7 **Approved amount:** \$72,525

Actual payment through June 30: \$72,525

#### **Project description:**

Country Corner Fire District Inc. is a Fire and Emergency Medical Service district serving approximately 22 square miles of Tulsa County in a Qualified Census Tract. Country Corner Fire District Inc. requested \$72,525 to purchase a used but reliable ambulance. Due to pandemic conditions, there has been a significant increase in 911 call volumes as a result of households contracting COVID-19. With an additional ambulance, the Country Corner Fire District's ambulance fleet now has two ambulances. The project was granted in accordance with Treasury expense category 1.7 quidelines.

## **Spring Shelter Support Services**

## Subrecipient organization:

The Spring Shelter

Treasury expense category: 1.11
Approved amount: \$110,900

Actual payment through June 30: \$110,900

## **Project description:**

The Spring Shelter requested \$110,900 to support mental health and substance use disorder services in accordance with Treasury expense category 1.11 guidelines.

## Additional information provided by the recipient:

The project to increase onsite substance use disorder services and mental health services began in March 2022. To date, since the project began, The Spring Shelter has increased its on-staff number of Certified Peer Recovery Support Specialists from one (1) to two (2), thus increasing the availability of and access to onsite substance use disorder support by 80 hours per week.

Additionally, The Spring Shelter doubled its offerings of group therapy specific to the children they serve.

# **Tulsa County Alternative Courts Social Distancing**

## **Project description:**

Alternative Courts social distancing program, led by the Tulsa County District Court requested \$62,507 to build cubicles and separate workspaces that would help protect employees and clients within congregate settings. Prior to these separated spaces, it was common to gather many people in one crowded area. This has enhanced the health and public safety of hundreds to people involved in the court system. The project was considered and awarded in accordance with Treasury expense category 1.4 guidelines.

## **Project description:**

The Tulsa Area Emergency Management Agency requested funds for rapid COVID-19 testing for Tulsa County employees and affiliates. The project provided approximately 2,000 tests for use in Tulsa County. This project was awarded based on Treasury expense category 1.2 guidelines.

# **BA Seniors HEPA Filtration Equipment**

## **Project description:**

The City of Broken Arrow requested funds on behalf of the Broken Arrow Seniors program for air filtration at the local Senior Center. The broken Arrow Senior Center provides programs, health clinics, classes and events to the seniors in the Broken Arrow area. This project supported the activities of senior citizens in the Broken Arrow area and was awarded based on Treasury expense category 1.4 guidelines.

## **TAEMA Children's Masks**

#### **Project description:**

## **Project description:**

The Tulsa Day Center requested funds to provide care for underserved and disproportionately impacted communities. The center operates a clinic that was fully operational throughout the entirety of the pandemic. These funds were requested to provide COVID-19 screening and testing. This project will also implement mental health screenings with a streamlined referral to telepsychiatry care provided at the clinic. The Tulsa Day Center operates in a Qualified Census Tract. This project was awarded under Treasury expense category 1.14.

# **Crossover Community Center Expansion**

Crossover Community Center Treasury expense category: 2.24 Approved amount: \$4,000,000

Actual payment through June 30: \$4,000,000

## **Project description:**

The project was requested by Crossover Community Impact, a non-profit organization established to enhance the lives of children and families in disproportionally impacted communities. This center will house the Crossover Preparatory Academy which will work to close the education gap for children who reside in QCTs surrounding the location. The facility will provide free internet connectivity and a curriculum including food services and meals in an area that was highly impacted by the pandemic. The Crossover Community Center project is underway in a qualified census tract in North Tulsa. This project was awarded funding in accordance with Treasury expense category 2.24 guidelines.

## **Airline Support Project**

## **Project description:**

The Airline Support Project was requested by the Tulsa Community Foundation and the Tulsa Regional Chamber as an economic and tourism development project but also to help aid the impacted airline industry which has deep roots in the Tulsa County region. This project helped ensure at least two new direct flights in and out of the Tulsa International Airport, which has enhanced the abilities of businesses to operate in Tulsa as well as helped individuals and businesses related to tourism. This project was awarded in accordance with Treasury expense category 2.35 guidelines.

## **The City Lights Village Project**

The City Lights Foundation of Oklahoma Treasury expense category: 2.34 Approved amount: \$600,000

Actual payment through June 30: \$600,000

#### **Project description:**

The City Lights Foundation of Oklahoma requested \$1,000,000 to meet the demand for affordable housing in Tulsa County. The City Lights Village is a permanent, supportive housing development for individuals experiencing chronic homelessness. The village will consist of 75 homes in a community with access to resources such as financial empowerment center classes, tenant and landlord counseling, mental health and addiction recovery resources, on-site housing stability support, a community center, laundry facilities, a community garden and meeting spaces.

These funds were awarded in accordance with Treasury expense category 2.34 guidelines.

## **Family Safety Center Expansion**

## **Project description:**





## **Project description:**

The Tulsa Film Support Program project was requested by the Tulsa Regional Chamber, Visit Tulsa and the Tulsa Office of Film Music and Culture. Specifically, it created the Film Tulsa Fund which is available for productions meeting specific criteria and is designed to grow the Tulsa County workforce by boosting the film industry.
