## **GENERAL OVERVIEW**

# **Executive Summary**

The effects of the COVID-19 pandemic were far reaching and had significant impacts across the Country. Lorain County was no exception. With the SLFRF funding received by the County, the intended plan is to maximize the use of funds to have a wide-reaching effect on the general well being of the County and its residents. The County will be using plans spanning assistance to non-profit agencies, grants to community partners to further projects aimed to combat negative effects on the public caused by the pandemic, renovations to allow for better social distancing, aid to revitalize county tourism and revenue recovery to allow the County to continue to provide necessary and vital public services with the aim of getting the County back on the path to recovery.

#### **Uses of Funds**

In order to help support a strong and equitable recovery from the COVID-19 pandemic and economic downturn the County has put an emphasis on spreading the funds across a wide array of projects in order to maximize the impact of the funding towards recovery.

The pandemic had a traumatic effect on Public Health. Aside from the obvious physical health issues the pandemic also took a disastrous toll on the community's mental and psychological well-being. To that end, the County intends to use the funds to support not only promote resident's physical health but also to try to combat many of the other negative impacts to County health. The County has committed funding to cover Flu Shots for the residents, funding to area partners to address County food insecurities and funding to support the fight against substance abuse that was magnified during the pandemic.

Funding is also going to be used to respond to the negative economic impacts of the COVID-19 public health emergency. Grant programs have been implemented for both small businesses and non-profits to apply for financial support towards recovery. In addition, programs have been put in place to get financial assistance to veteran organizations who were hit particularly hard by the economic downturn. Another area of emphasis the County intends to address with funding is the severe economic impact the pandemic had on County tourism. There are a number of potential projects being considered to bolster tourism all around the County.

SLFRF funding will allow the County to address several areas within County Government to allow for better, more efficient and safer service to the residents. Some of these areas include renovations to public spaces to allow for social distancing and investments in equipment and technology to allow for more effective response to public emergency and security needs.

Yet another allowable use of SLFRF funding is towards the improvement of water, sewer and broadband infrastructure. The County is currently in the initial stages of assessing need and reviewing specific sewer, water and broadband plans.

Finally, the economic downturn caused by the Pandemic has had a serious effect on our local government revenue. The U.S. Treasury guidance provided calculation for how to determine a County's lost revenue over the period of 2020-2023 when compared to the base year of 2019. Based on this calculation, it has been determined that in 2020, 2021 and 2022, the County General Fund has lost a total of \$20,009,322.19 in Revenue for those three years. It is projected that over the 4-year span of 2020-2023 that total will exceed \$30 million. To date the County has earmarked that \$20,009,322.19 in SLFRF funds towards General Fund revenue recovery. Those funds are being used to supplement funding towards government services provided by the County as per regulations laid out in the ARP final fuling.

# **Community Engagement**

The County Commissioners have continued throughout the process to be open to outside suggestions and ideas for ways to best use the funding. Ideas and requests continue to come in from both County Leadership, County municipalities, County Partners, Business Leaders, residents, etc. Requests are taken and then reviewed against needs assessment, and run through the leadership team and Legal Counsel to determine the project meets allowable requirements for SLFRF Funds. Once, it is determined there is a need and it is allowable, the County Commissioners then determine if they have a desire to commit SLFRF funding towards the project and pass a Resolution should that be the case.

#### **Labor Practices**

As a general County practice for all applicable County projects, whether funded by SLFRR funds or not, the projects are geared towards using strong labor standards to promote effective and efficient delivery of high-quality projects. When applicable and allowable the County requires contractors to utilize prevailing wages for County financed projects and again when allowable, preference is always given to local providers.

WHEREAS, Neighborhood Alliance is soliciting assistance from Ohio Development Services, private individual contributions, including individuals and foundations, as well as public support for assistance with this project; and

WHEREAS, construction of the Neighborhood Nutrition Kitchen for Lorain County residents would allow Neighborhood Alliance to;

- · Eliminate the waitlist of home delivered meals;
- · Provide 350,000 (or more) nutritious home delivered meals annually by 2026;
- Offer nutritious meals for seniors, children and shelter residents that encompasses dietary restrictions, food sensitives and cultural diversity;
- · Provide nutritious meals for adults under age 60 who are not eligible for funding from Older Americans Act;
- Provide nutritious meals for disabled, low income individuals ages 50 to 60;
- · Pilot a summer child hunger program in which meals ware provided to children in underserved neighborhoods or food deserts;
- Reinstitute congregate meals for seniors 55+ which provides a nutritious, safe and appealing meal in a group setting that promotes socialization, health and wellbeing;
- · Reduce the food costs by 40% per meal;
- · Become self-sustainable.

NOW, THEREFORE BE IT RESOLVED, by the Lorain County Board of Commissioners that we find the construction of the Neighborhood Nutrition Kitchen will assist Lorain County residents as they recover from the economic and social disruption caused by the COVID-19 pandemic; and

BE IT FURTHER RESOLVED, that we authorize a contribution from the American Rescue Plan Funds, Acct#1060.0000.100.000.01.7070.0000 in the total amount of \$500,000 to Neighborhood Alliance, Lorain, Ohio. Said funds to be used for the construction of said Neighborhood Nutrition Kitchen.

WHEREAS, the Lorain County Board of Commissioners seeks to dedicate funds in an amount up to \$250,000.00 to assist veterans service organizations throughout Lorain County under the authority of R.C. 307.85, in furtherance of its administration of federal financial assistance in response to the COVID-19 pandemic; and

WHEREAS, the funds herein dedicated will consist of funds received under the American Rescue Plan Act, to assist in managing aftereffects of the COVID-19 pandemic; and

**Project Overview** 

WHEREAS, mental health and recovery services are crucial to the well-being of the residents of Lorain County; and

WHEREAS, in large part because of the COVID-19 pandemic, there has been a significant increases in both addiction and poor mental health outcomes in Lorain County and throughout the nation; and

WHEREAS, The Road to Hope is striving to meet the need to assist individuals and families who have been adversely affected by addiction by repurposing existing structures to be used as recovery housing for women, children and families called the Village Project; and

WHEREAS The Road to Hope is seeking and has received funding for this project from a number of governmental entities and private foundations; and

WHEREAS, in accordance with ORC 307.85, the Lorain County Commissioners authorize a commitment of funds in the amount of \$500,000 toward the construction of the Village Project. The Board intends to use funds made available through the American Rescue Plan and funds that will be made available as a result of the recently executed Opioid Settlement Agreement to satisfy its pledge.

NOW, THEREFORE BE IT RESOLVED, that the Lorain County Commissioners authorize a commitment of funds in the amount of \$500,000 to Road to Hope for use in establishing the Village Project.

WHEREAS, the American Rescue Plan Act contains provisions permitting such State, Local, and Tribal governments to reimburse their respective budget shortfalls with funds provided under the act; and

WHEREAS, it will greatly benefit Lorain County to use of American Rescue Plan Funds to reimburse COVID-related shortfalls to its General Fund; and

WHEREAS, through consultation with the county's budget director, the Lorain County Board of Commissioners has determined the appropriate calculation of the amount of funds needed to adequately reimburse Lorain County's COVID-related shortfalls to its General Fund, in accordance with enacted regulations promulgated in association with the American Rescue Plan Act;

NOW, THEREFORE BE IT RESOLVED, that the Lorain County Board of Commissioners shall use American Rescue Plan Act funds to reimburse its COVID-related shortfalls to its General Fund, as determined by the Lorain County budget director, in the amount of \$1,449,753.59.

Without this funding, the SRT's would be seriously disadvantaged in operational ability.
