GENERAL OVERVIEW

Executive Summary

To respond to the public health emergency with respect to Coronavirus and it's impacts, the Municipality of Anchorage has taken a proactive approach to provide tools and resources to communities, residents, and businesses. In the initial process, the Anchorage Assembly and Municipality of Anchorage (MOA) Mayor's Office worked to identify the harmful effect of COVID-19. These entities spent two months to identify the needs of Anchorage residents and businesses; convened meetings and townhalls with members of the public, businesses, nonprofits, and social service groups; conducted two separate day-long meetings on March 19th and March 26th to develop the framework, guiding principles, and proposed relief measures in the resolution for ARPA use of funds.

The Municipality of Anchorage was awarded \$103,317,366 in Federal ARPA State and Local Fiscal Recovery Funds and chose to receive their funds from the Federal Department of Treasury in two tranches. The first tranche of funds in the amount of \$51,658,683 was disbursed to approximately 90 subrecipients in 2021. The second tranche of funds is planned to be disbursed in 3rd quarter 2022.

This second annual MOA Recovery Plan report is meant to be both descriptive of past performance and proscriptive of future efforts to report back to the community of specific uses of funds, equity frameworks and indicated outcomes.

Uses of Funds

The goal of the Municipality of Anchorage was to support through funding a strong and equitable recovery from the effects of the COVID-19 pandemic and its subsequent economic downturn. The intended uses of the funding was allocated to specific Expenditure Categories (EC) as identified by the Federal Government. The funds were used specifically to support individuals, families, communities, and organizations throughout the municipality that were adversely affected by the pandemic. Public Health (EC 1) - no funds allocated

Negative Economic Impacts (EC 2) — The negative impact of the COVID-19 pandemic not only affected the local economy but also services and resources to our community. The funds used in this category addresses how our allocations were spent to assist these areas in need. For this category, the municipality awarded funds to various organizations to remain sustainable and help those in our community recover from the negative impacts of the COVID-19 pandemic. This allowed us to rebuild our economy in ways that enhance our self-sufficiency and reduce vulnerability to supply chain. These awards protect our economy and the health and wellbeing of our city's residents, businesses, and nonprofits.

These awards include:

- Aid to nonprofit organizations for voucher distributions to families for daily expenses, skill training & job search assistance, and operational expenses to keep nonprofit doors open
- Programs that address the immediate needs and barriers for underserved and unemployed youth, families, and adults
- Small business economic assistance for business personal property tax relief and stabilization grants

- Tourism business relief grants
- Relief for tourism businesses experiencing hardships
- Websites for accessible job search assistance
- Community outreach for small businesses that provide resources for government services
- Assistance to families to access federal benefits and relief funding
- Repair, expand, and upgrade food pantry/storage and distribution facilities

Public Health-Negative Economic Impact: Public Sector Capacity (EC 3) - Prior to the COVID-19 pandemic, our city has had many challenges with providing tools and resources for our venerable homelessness community. With the ARPA relief funds, the Anchorage Assembly was able to collaborate with key community non-profits and activists to expand and fund housing assistance.

<u>Housing Assistance & Support:</u> Part of the funding in this category was used to support the rapid rehousing of homeless youth transitioning out of shelters, and to provide temporary housing awaiting host home placement. Funding also provided for housing, addiction treatment, vocational training for the homeless, and transitional housing for homeless young adults 16-24 years. Part of the funding in this category was used to hire housing intensive case managers to help people transition out of homelessness especially those who did not qualify for the federal rental relief.

<u>Healthy Childhood Environment, Education, Mental Health & Social Services:</u> Funded school based mental health services for children and youths mental health needs exacerbated by the pandemic. Funds a social media campaign to help recruit foster homes. Provides funding for the expansion of a public health clinic and for the purchase and installation of "COVID-proofing" equipment and systems at the clinic.

<u>Data System:</u> Funds were used to expand a data system that will track and analyze performance measures. There's also a component that will track success and challenges and report monthly to the Anchorage Assembly Committee on Housing and Homelessness on barriers and progress.

Premium Pay (EC 4) - No funds allocated

Water, sewer, and broadband infrastructure (EC 5) - There is one broadband project to provide broadband capacity, internet services and security cameras to the Chugiak-Eagle River Senior Center.

Revenue Replacement (EC 6) -

<u>Government Services</u>: During the COVID-19 pandemic many government departments saw an increase in their expenses to provide services to their employees. There was also a decline in revenue to due mandatory shutdowns which caused many user fees that government relies on to be waived and/or postponed to a later date.

For many of the local government entities, the grant relief focuses on the following economic harm:

Covering payroll

- Mortgages or rent for buildings
- Operating costs
- Providing sick leave resources to employees

Recovery: Funds were allocated to connect unemployed workers with job opportunities. Grants included a comprehensive job search tool that would benefit both the employer and the future employee.

<u>Misc:</u> Other grant funding was used for improving direct services to citizens. These government services included road infrastructure, increasing public safety measures, environmental revitalization, and other local government improvements.

Promoting equitable outcomes

The Assembly looked to frame disbursements to serve, and support identified underserved and disadvantaged communities within the municipality of Anchorage.

- a. Goals: The Assembly identified underserved communities including:
 - Youth 18-24 Grants for youth displaced from their homes or traditional care due to the pandemic.
 - Homeless Grants to provide services, support, resources, and temporary and permanent housing to this vulnerable and underserved population.
 - BIPOC community Grants to provide services and support in addition to economic recovery, education, and community action for this community.
- b. Awareness: Grants were given to businesses and non-profits to promote awareness of services and resources provided by ARPA funds. Specific grants were targeted for outreach to BIPOC and underserved communities.
- c. Access and Distribution: Grants were distributed to organizations that provided much needed resources and services at the individual and street level. Realizing that many of the hard to reach and marginalized communities have difficulty accessing resources due to fear or lack of knowledge, grants were disbursed to organizations that work with specific underserved populations and are proactive at collaborating with these recipients and beneficiaries.
- d. Outcomes: Under the lens of promoting equitable outcomes the Assembly and the Mayor's office have the intention of providing equal services to all the citizens of Anchorage including the homeless, the marginalized and others from historically disadvantaged communities. Our grant reporting including our Quarterly Project & Expenditure reports that are located on the Municipality website and indicates specific metrics and numbers of those served and in the upcoming year we will engage in surveys, questionnaires, and community meetings to further provide numbers and data.

Specifically, the Municipality of Anchorage has put an emphasis on funding Negative Economic Impacts (EC 2) to address areas of promoting equitable outcomes. Grants in Expenditure Category 2 include: assistance to households, small businesses, and non-profits to address impacts of the pandemic which have been most severe among low-income populations. This also includes assistance with food, housing, and other needs; employment programs for people with barriers to employment who faced negative economic impacts from the pandemic (such as

residents of low-income neighborhoods, minorities, disconnected youth, the unemployed, formerly incarcerated people, veterans, and people with disabilities); services to provide long-term housing security and housing supports, address educational disparities, or provide child care and early learning services; and other strategies that provide impacted and disproportionately impacted communities with services to address the negative economic impacts of the pandemic. These projects are further defined in the project narratives.

In 2022 the Municipality of Anchorage Mayor's office began acquiring quantitative report data to assess and report back on the equitable distribution and serving of various underserved and disadvantaged communities. Though proscriptive future surveys and report backs the Mayor's office will provide data for the governmental entities and the public to assess. Specific numerical goals were not addressed in this first tranche of ARPA SLFRF funding, but there may be an opportunity to establish and set numerical goals for equity in the 2nd tranche of SLFRF funding.


There were few challenges in the disbursement of the first tranche of MOA ARPA funds to the subrecipient organizations. All 70 subrecipients have entered contracts with the Municipality of Anchorage, though approximately 3 did not have contracts finalized until the 2nd quarter of 2022. There have been some challenges for a small number of subrecipients in the expenditure of their grant funding due to capacity, internal resources, or sourcing of product/materials.

The Municipality of Anchorage Assembly members (who represents a specific geographic area) engaged in a process to ensure that each Assembly district had funds distributed to their specific geographic area. Realizing that certain districts contained traditionally marginalized communities the distribution was targeted to allow increased funding to these areas that demographically contained most of the marginalized and underserved individuals and nonprofits.

Community Engagement

Beginning in 2022 the Assembly and the Mayor's office has promoted and engaged in 5 "ARPA Investment Reviews". This series of in person and online sessions allowed the Assembly and community to hear back from the subrecipients as to their use of grant funding and the positive impact it has had for their organizations/businesses and the community. This upcoming year the Mayor's office has planned more engagement (and data) through increased surveys, interviews, digital campaigns, community meetings to engage and capture more information both quantitative and qualitative from diverse subrecipients, community members and stakeholders.



Labor Practices

As of the last April Project & Expenditure report there were no tracking of infrastructure projects. In future Performance reports we will track and will report back as to labor practices including project labor agreements, community benefits agreements, prevailing wage requirements, and local hiring for the limited number of funded infrastructure projects.

Use of Evidence

The Municipality did not incorporate into their first tranche SLFRF program funding evidence-based interventions and/or program evaluations. As a proscriptive practice the Assembly and Mayor's office will consider whether to fund evidence-based interventions and evaluations will be applicable to the 2nd tranche of funding.

Performance Report

The municipality of is presently tracking performance of their ARPA SLFRF through report backs, quarterly expenditure and project reports and discussions/conversations with subrecipients as to challenges and concerns in implementing their projects. The key performance indicators that we have tracked as of the June 30 for the first tranche of ARPA funding are number of households served and does it include a capital project and total capital expenditure. As a proscriptive remedy the municipality of Anchorage is working on more robust and detailed evidence and data driven key performance indicators for future and 2nd tranche reporting. Key performance indicators in presently in place are indicated in the Project Inventory section below.

Project Overview

Distributing gift cards to families and individuals impacted by COVID-19 throughout the municipality of Anchorage. Gift cards could use for food, household items, gas, or supplies for kids.

<u>Project Use of Evidence</u>

The goal of the project was to provide gift cards to individuals and families that were adversely affected by the pandemic. The first tranche of MOA ARPA grant funding was not disbursed with a lens of evidence based interventions in place and are not at this time being evaluated through program evaluations designed to build evidence. As a proscriptive measure the Municipality of Anchorage will look to funding and support to identify contractors and personnel to provide data including the dollar amount of total project spending that is allocated towards evidence-based interventions.

<u>Project Performance Report</u>

The Business Boutique served over 8,590 Anchorage households as their key performance indicator. This was measured by number of gift cards distributed and tracked by staff.

Project Overview

This grant funded the fourth round of the COVID-19 Small Business Stabilization Grant Program which funded all the businesses that remained on the waitlist from previous rounds. The program provided \$10,000 grants to eligible small businesses who had been harmed by the pandemic. Funds could be used for operating expenses including rent, utilities, and vendor payments. Eligible businesses were those that earned less than \$2 million in revenue in 2019, are in the Municipality of Anchorage, and are not restricted to patrons over the age of 18 or 21 and were open and in operation on or before March 1, 2020. If the business is a sole proprietorship, single member LLC, or single-shareholder corporation, the business income must account for 75% of the owner's total income.

During the grant period, CILC collected the documents required to transfer the funds, had grantees sign the grant agreement and eligibility attestation, and sent the funds via a wire transfer or check. Originally there were 834 businesses slated to be funded in Round 4. While CILC attempted to contact every grantee multiple times via phone and email, some grantees did not respond to our request to submit their documents by the deadline and were withdrawn. Additionally, some businesses were determined to be ineligible. The program funded 703 businesses. All eligible waitlisted businesses who submitted the required documents were funded. CILC returned the remaining funds to the MOA.

Project Use of Evidence

The goal of the project was to provide grant funding to businesses that were adversely affected by the pandemic. The first tranche of MOA ARPA grant funding was not disbursed with a lens of evidence based interventions in place and are not at this time being evaluated through program evaluations designed to build evidence. As a proscriptive measure the Municipality of Anchorage will look to funding and support to identify contractors and personnel to provide data including the dollar amount of total project spending that is allocated towards evidence-based interventions.

<u>Project Performance Report</u>

The program funded 703 businesses. All eligible waitlisted businesses who submitted the required documents were funded.

Project Overview

The ARPA Tourism & Convention Re-Marketing Program Grant, awarded to Visit Anchorage by the Municipality of Anchorage in June 2021, had a huge impact on Visit Anchorage and the many local tourism businesses struggling to recover from the devastating effects of the COVID-19 pandemic. Visit Anchorage generated interest in Anchorage as a visitor destination and fueled broad economic benefits by implementing of a wide range of creative and effective tourism marketing programs, producing promotional materials, and coordinating educational presentations and appointments at travel tradeshows and meeting planner events. The grant generated interest in travel to Anchorage, encouraged bookings, inspired visitors to explore the city's wide-open spaces, and promoted the experiences and culture of our place. Increased visitation translated into increased visitor spending, benefiting local businesses working to get back on track. Hospitality and service sector employees returned to work as visitor interest in Anchorage grew. In an encouraging sign, several airlines responded to the increased demand by introducing new direct flights from major U.S. cities. Throughout the summer months, Anchorage saw hotel occupancy rates rise and bed tax revenue increase.

Project Use of Evidence

The goal of the project was to provide marketing support of the Visit Anchorage and tourism in Anchorage. The first tranche of MOA ARPA grant funding was not disbursed with a lens of evidence based interventions in place and are not at this time being evaluated through program evaluations designed to build evidence. As a proscriptive measure the Municipality of Anchorage will look to funding and support to identify contractors and personnel to provide data including the dollar amount of total project spending that is allocated towards evidence-based interventions.

The \$3 million in ARPA funds directed to the Tourism Grant Program provided for a continuation of a business grant program first initiated by the Municipality of Anchorage (MOA) using funds from the CARES Act. The objective of the ARPA funded round – the program's third round – was to support and preserve business connected to Anchorage travel and tourism still suffering lasting negative effects of COVID-19. Round three of the MOA Tourism Grant Program provided grants to travel and tourism businesses with continuing economic hardship in 2021 due to the COVID-19's lingering effects on leisure, business, and convention travel. Funds were distributed as grants that eligible businesses could use to offset lost revenues and the negative effects of COVID-19 in 2021.

Visit Anchorage partnered with the MOA to administer the program and distribute the funds. Visit Anchorage staff managed the day-to-day operations for the program. An external panel comprised of six individuals from local non-profit partners outside tourism and non-tourism business leaders provided oversight. The panel reviewed eligibility criteria, suggested changes before each application period opened, and approved final criteria and determinations on eligibility. Qualified businesses in the MOA were eligible for one of four tiers of relief grants based on company size as determined by each businesses' gross receipts in 2019. Of the \$3 million, \$2,855,080.50 – more than 95% – was distributed in the form of business relief grants. With the remainder left as an administrative fee.

The first tranche of MOA ARPA grant funding was not disbursed with a lens of evidence based interventions in place and are not at this time being evaluated through program evaluations designed to build evidence. As a proscriptive measure the Municipality of Anchorage will look to funding and support to identify contractors and personnel to provide data including the dollar amount of total project spending that is allocated towards evidence-based interventions.

Project Overview

This grant funded the second rounds of the COVID-19 Nonprofit Stabilization Grant Program and the Individual Artist Awards Program which provided support to nonprofits and individual working artists who were harmed by the pandemic. This round funded applicants from the first round of

each program that were initially placed on a waitlist. For nonprofits, there were three award amounts based on the revenue of the nonprofit—those with revenues less than \$250,000 were awarded \$7,500, those with revenues between \$250,000 and \$1 million were awarded \$15,000, and those with revenues greater than \$1 million were awarded \$30,000. Nonprofits were permitted to use the funds for operating expenses and expenses related to expanding critical charitable services to address the pandemic.

Nonprofits were permitted to use funds to cover costs already incurred due to the pandemic and to replace lost revenue from canceled fundraising events. For individual artists, each grant was \$5,000. Originally, there were 28 nonprofits slated to be funded in this round. Two nonprofits were withdrawn because they were ineligible or opted out of the program; two additional nonprofits had applied under the incorrect revenue tier and were shifted down to the correct tier. Four individual artists either did not respond to multiple requests to submit documents or were determined to be ineligible. All eligible waitlisted nonprofits and artists who submitted the required documents were funded—26 nonprofits and 156 artists in total. CILC returned the remaining funds to the MOA.

Project Use of Evidence

This grant funded the second rounds of the COVID-19 Nonprofit Stabilization Grant Program and the Individual Artist Awards Program which provided support to nonprofits and individual working artists who were harmed by the pandemic. The first tranche of MOA ARPA grant funding was not disbursed with a lens of evidence based interventions in place and are not at this time being evaluated through program evaluations designed to build evidence. As a proscriptive measure the Municipality of Anchorage will look to funding and support to identify contractors and personnel to provide data including the dollar amount of total project spending that is allocated towards evidence-based interventions.

Project Overview

ACPA – Alaska Center for Performing Arts Cultural Pillars Round 2 support received by Alaska Center for the Performing Arts, Inc. (ACPA) ensured our sustainability through 2021, making it possible to retain specialized staff with critical expertise to run this theatrical facility. ACPA reopened the PAC in 2020, however event availability was limited to a few small community programs as mandates continued to fluctuate. In the first half of 2021, ACPA continued to experience limited programming due to the major impacts of COVID on our ten Resident Companies and other building users. ACPA

focused on developing live streaming capabilities from all theatres and creating new events/programs to engage and build community. In the summer of 2021, ACPA successfully produced a free Summer Arts in the Park program in Town Square Park, featuring 24 artists/groups, in collaboration with Anchorage Downtown Partnership and Anchorage Museum sponsored by the Atwood Foundation and other community partners. ACPA also produced a new series called PACFlix in August 2020, with a series of Monday night movies with complementary interactive activities in our lobbies. With the return of our regular season in September, we offered hybrid events with inperson and streamed options to support audiences' varying comfort levels attending and experiencing the live performing arts. Through December, we continued to see significant fluctuations/cancellations/rescheduled programming due to delta/omicron variants. We remain committed to working with each building user to pivot and shift events as necessary, expand new programs and continue to focus on maximizing safe use of the facility.

ANHC - The Alaska Native Heritage Center has utilized the ARPA grant funds from the Municipality of Anchorage to execute a website redesign which will facilitate easier access to cultural materials for individuals who may be forced to isolate due to COVID-19. The new website will also facilitate e-commerce activities and marketing/promotion of ANHC as a tourism attraction, which will allow for a strong economic recovery from the devastating impacts that COVID-19 had upon the tourism industry in Alaska.

AWCC – Alaska Wildlife Conservation Center The grant was used for initial intended purposes of personnel expenses, health and workers compensation insurance, safety expenditures, IT services, building and grounds maintenance, equipment and vehicles expenses, and utilities.

Alaska Zoo - The Alaska Zoo's mission is to promote conservation of Arctic, sub-Arctic and like climate species through education, research, and community enrichment. The funds were used to support the Alaska Zoo's mission and continue operation and heal from the pandemic. Anchorage Museum - The grant funds provided operational support towards salaries for 65 staff members at the Anchorage Museum. Grant funds supported basic operations of the Anchorage Museum, focused on salary for full-time staff members, retaining 65 employees. During the grant period (period ending 12/31/2021), the employees served community needs providing virtual content and programming, education and curriculum development and support for the Anchorage School District, and teachers and students statewide, as well as free educational resources for parents.

Project Use of Evidence

The goal of these grants were to provide support to specific Anchorage cultural nonprofits that were adversely affected by the pandemic. The first tranche of MOA ARPA grant funding was not disbursed with a lens of evidence based interventions in place and are not at this time being evaluated through program evaluations designed to build evidence. As a proscriptive measure the Municipality of Anchorage will look to funding and support to identify contractors and personnel to provide data including the dollar amount of total project spending that is allocated towards evidence-based interventions.

The Restaurant and Hunger Relief program was created by the Alaska Hospitality Retailers Association, the United Way of Anchorage, and the Municipality of Anchorage with the support and contributions of many partners, including the Rasmuson Foundation and the Alaska Community Foundation and approximately 200 individual donors. Modeled after programs being implemented as economic development relief during the COVID-19 pandemic, this program was implemented in November of 2020 to purchase meals from local restaurants chosen in lottery drawings, and to provide them to non-profit community service locations, housing programs for low-income families and individuals, and to the elderly. This unique approach helped the community by supporting local businesses who struggled during 2020-2021 with the pandemic mitigation protocols, reductions in customers and in maintaining staffing as employees quarantined and isolated for their own conditions or with others in their households. Many of these restaurants continue to struggle with labor shortages and other challenges and have reported to the project sponsors that this program was key to them keeping their doors open over the past 2 years.

Project Use of Evidence

The goal of the project was to purchase meals from local restaurants chosen in lottery drawings, and to provide them to non-profit community service locations, housing programs for low-income families and individuals, and to the elderly. The first tranche of MOA ARPA grant funding was not disbursed with a lens of evidence based interventions in place and are not at this time being evaluated through program evaluations designed to build evidence. As a proscriptive measure the Municipality of Anchorage will look to funding and support to identify contractors and personnel to provide data including the dollar amount of total project spending that is allocated towards evidence-based interventions.

Project Performance Report

The project's key performance indicator included the ability to help 65 different restaurants with a total of 34 service sites receiving 264,338 meals as of January 31,2022. More than 3,500 individuals received meals over the course of the 26 months of the program. The COVID-19 pandemic has created not only financial distress for many workers and businesses, tenants and homeowners, and families but it has also created new legal issues. Rapidly changing laws have meant there is a great deal of confusion relating to individuals rights and responsibilities and this confusion has left many vulnerable community members unprotected on issues relating to their employment (for instance accessing unemployment benefits, on issues relating to workplace safety), their housing, as well as their family stability.

Alaska Legal Services Corporation (ALSC) will dedicate 2.0 FTE staff attorneys to address the unmet critical civil legal needs of Anchorage residents who have been impacted by the pandemic and are financially distressed. The program will help qualifying residents of Anchorage address the unmet civil legal needs that are destabilizing their households. The project staff will also educate the community about the rights and responsibilities under various pandemic-related relief measures (such as the CDC moratorium) to prevent illegal evictions and foreclosures and help workers obtain pandemic related programs protections. ALSC will screen all its applicants for income eligibility.
