Dear ECIP Participants:

We are reaching out regarding the Quarterly Supplemental Reporting process, and tools which will be available going forward to make the process clearer for everyone. Apologies in advance for the lengthy, but information-dense email. The body of this email is also included as an attached PDF for your records.

The ECIP Team greatly appreciates the hard work of all the Participants to submit timely Quarterly Supplemental Reports. Based on our experience in 2023, we are introducing updated instructions, templates, and expanding technical assistance resources.

QSR Instructions: A revised version of the QSR Instructions will be available on the ECIP website
and IMPACT Portal in the coming days. These new documents contain more thorough and clear
instructions, and more illustrative examples of how various loan types would be entered into
the QSR.

While the vast majority of the updates to these documents are simply clarifications, there are three important *changes* to the instructions:

- 1. The Deep Impact Lending category of "Underserved Small Business" is now simply called "Underserved Business". The definition of this category remains the same.
- 2. The definition of the category "Qualified PWI" has been explicitly expanded. In addition to projects benefitting LMI borrowers and communities (the previous definition), projects benefitting Minority borrowers or businesses will also qualify as Qualified PWI. This definition now explicitly ensures that all Qualified PWI encompasses all Deep Impact PWI as well.
- **3.** Participants will submit 5 QSR reports (5 Excel files) for each year of data, 4 quarterly reports with Schedule A & B data, and one annual report with Schedule C & D data. The reports will be labeled by quarter and "Annual" in the IMPACT portal. Upcoming reporting due dates are outlined below:

• QSR Template: We have created a revised version of the QSR Template, which must be used for the QSRs due 1/31/2024 and all QSRs going forward. The new templates can be found here:

This new template will look almost indistinguishable from the template you are already using, as the vast majority of the updates are hidden tools incorporated into the template which allow for more efficient reviews of the QSRs.

Therefore, **it is paramount** that you assure you have downloaded the updated template when you begin working on your 2023 Q4 QSRs due 1/31/2024. An easy way to identify if you are using the new version of the template will be the presence of a "Rubric" as the first tab in the Excel. This tab lists some of the data validation checks we complete on the QSR once it is submitted so that you may check them yourself. The new template is available to download on the ECIP website at the link above, and will be available to download within the IMPACT portal.

- Explanatory Video: We recorded a short video which explains the categories of Qualified Lending and Deep Impact Lending and reviews how to complete the QSR. This video is available on the ECIP website, and here: https://youtu.be/CtMjd9E88u0
- QSR Office Hours: The team will also host quarterly office hours over Zoom to review the QSR instructions and take questions from participants. These office hours will be held twice per quarter, several weeks before each QSR submission deadline. The schedule of office hours for 2024 can be found below:

We'd also like to take this opportunity to remind you that per Section I.G of the QSR Instructions:

• In the Narrative uploaded with the QSR, you must also include a description of yours plans to implement sufficient demographic data collection systems and your progress in implementing those plans. The narrative must also include an estimate of the number and dollar value of originations of loans or investments during the reporting period for which demographic data was not collected, expressed as a percentage of Total Originations as reported on Schedule A.

For each QSR through the report for Q2 2024, Treasury will not consider the QSR to be
inaccurate or incomplete solely on the basis of a lack of demographic data. Beginning with the
QSR covering Q3 2024, Treasury will consider a QSR to be inaccurate and incomplete if the
Participant is not collecting sufficient demographic data to enable them to complete all the
fields and schedules in the Quarterly Supplemental Report.
