## **GENERAL OVERVIEW**

# **Executive Summary**

Webb county has received all the \$53,736,408 it was allocated from the US Treasury American Rescue Plan Act (ARPA) State and Local Fiscal Recovery Funds (SLFRF). As per the Interim Final Rule, SLFRF funds may be used for four main purposes:

- 1. To respond to the public health emergency or its negative economic impacts, including assistance to households, small businesses, and nonprofits, or aid to impacted industries such as tourism, travel, and hospitality.
- 2. To respond to workers performing essential work during the COVID-19 public health emergency by providing premium pay to eligible workers.
- 3. For the provision of government services to the extent of the reduction in revenue due to the COVID–19 public health emergency relative to revenues collected in the most recent full fiscal year prior to the emergency; and
- 4. To make necessary investments in water, sewer, or broadband infrastructure.

Webb County has approved a listing of projects that are eligible under the American Rescue Plan Act Funds. This approved list is the result of efforts by the ARPA Review Committee, who worked with county departments to receive inputs for proposed projects and then developed a final list for approval by the Commissioner's Court. In developing the list, the ARPA Review Committee discussed the current needs of each county Precinct with their designated elected officials to ensure the impact goals of the ARPA SLFRF program would be met with each project.

As part of the ARPA SLFRF program, Webb County was able to sub-award \$2,147,708.00 of its funds split across 11 Non-Governmental Organizations (NGOs) for use in projects approved by the county ARPA Review Committee and Commissioners Court (One NGO did subsequently return their funds). Each awarded NGO submitted a letter of intent and project application and was awarded through the approval of Commissioner's Court. The ARPA Review Committee reviewed each application in detail to ensure proposed projects would be eligible. After awarding eligible projects, the NGOs were required to participate in a workshop with the Webb County Economic Development Department. Department personnel explained in detail what would be required of each NGO to utilize the funds and expressed the importance of following all federal requirements.

Overall, the past 12 months have seen steady progress made on all the various funded projects. There are 9 NGO's that have expended 100% of the current project allocation to fund objectives delineated in their executed agreements with Webb County. With the remaining 2 NGO's there are no expected delays that would prevent completion of all projects by the December 2025 prior to the 2026 deadline.



# **Uses of Funds**

Webb County continues to utilize the funds provided through ARPA to support post pandemic recovery efforts across the county and the impact the pandemic had on county operations and support programs. The ARPA funding will ensure that the County has the resources it needs to continue to respond to the pandemic. Under the legislation, funding can be used to address five areas:

- 1. Support ongoing public health response to COVID-19
- 2. Address negative economic impacts of the pandemic.
- 3. Replace public sector revenue loss.
- 4. Provide premium pay for essential workers.
- 5. Invest in water, sewers, and broadband infrastructure.

Webb County plans to distribute funding under the listed categories for the SLFRF American Rescue Plan:

- 1. Public Health (EC 1)
- 2. Negative Economic Impacts (EC 2)
- 3. Services to Disproportionately Impacted Communities (EC 3)
- 4. Premium Pay (EC 4)
- 5. Water, sewer, and broadband infrastructure (EC 5)
- 6. Revenue Replacement (EC 6)

The Committee's proposed projects were evaluated on March 13, 2022, at Commissioner's Court. On June 13, 2022, Webb County presented the final funding allocations to county projects. The finalized list approved \$1 million for premium pay, \$2,147,708 for Sub-recipient assistance programs, \$8,488,422.45 million for revenue replacement, \$1,282,000.00 million for administration costs, and approximately \$41,818,277.60 million for direct projects. Webb County has appropriated additional funding from other sources to assist in expanding some of those adopted projects to fulfill project objectives.

The Commissioner's Court and the ARPA Review Committee continue to work diligently to ensure all funds are spent according to ARPA rules and support the best interests of Webb County residents. Webb County hired a project manager in August of 2022 to assist with oversight and management of the ARPA program and all associated projects. As required by ARPA Guidelines, the County (via the project manager) continues to provide the public with regular updates on the funding and will do so through the duration of the grant program.

Webb County continues to evaluate each project monthly and as projects continue to progress up to completion as per program guidelines. All funds have been properly encumbered as per program guidelines with executed agreements through public meetings with Webb County Commissioners Court agenda item and formal action by the court.



Webb County ARPA spending continues to remain in line with the designated expenditure categories. The focus of the Webb County ARPA program has been on Category 1 (Public Health), Category 2 (Negative Economic Impacts), Category 3 (Services to Disproportionately & Impacted Communities), Category 4 (Premium Pay), Category 5 (Infrastructure), and Category 6 (Revenue Replacement) and Category 7 (Administrative Services) as listed in each category below:

## **Public Health (EC 1)**

Webb County is utilizing ARPA funds to enhance emergency response capabilities, especially in the more rural and isolated portions of the county. Funds have been allocated to construct a new fire station in south Webb County, where residents currently rely on the central fire station, thus lengthening response times. Additionally, Webb County has historically relied on the City of Laredo Emergency Operations Center (EOC) to coordinate large scale emergency event response efforts. ARPA funds have been designated to renovate an existing structure to establish a county EOC to help fill the gap in response to rural areas that the City of Laredo EOC cannot cover. These rural areas are where the most vulnerable Webb County residents reside, and this EOC will help safeguard and protect them in the event of a disaster. All ARPA projects adopted by Webb County that fit this eligible category and sub-category are listed below.

# **Negative Economic Impacts (EC2) and Services to Disproportionately Impacted Communities (EC3)**

The pandemic not only took a toll on State and Local governments and resources, but also on Non-Profit organizations. County Commissioners have provided grants to several Non-Governmental Organizations (NGOs) across Webb County to assist them in their recovery efforts as well. Some of the NGO projects fall within other EC categories, but the majority fall within EC2 and EC3 by providing services and resources to disproportionately or negatively impacted populations. These subawards of ARPA funds are being used by the non-profits to provide services like housing, food, and bill pay resources as well as tutoring for county children who were negatively impacted by the effects of on-line schooling. All ARPA projects adopted by Webb County that fit this eligible category and subcategory are listed below.

# Premium Pay (EC 4), Revenue Replacement (EC6), and Administrative Services (EC7)

Webb County Commissioners allocated \$1,000,000 of ARPA funds to cover premium pay for county personnel. Those funds have all been used, and no additional allocation of funding towards premium pay is anticipated. Additionally, \$10,000,000 was allocated by the Commissioners for Revenue Replacement projects, with \$8,488,422.45 of it currently aligned to a project. Webb County intends to expend for Administrative Services into 2025 & 2026 with a reduction of the allowable 10% totaling at \$5,373,640 to a reduction of budget to \$1,284,728.16. All ARPA projects adopted by Webb County that fit this eligible category and sub-category are listed below.

# Water, Sewer, and Broadband Infrastructure (EC 5)

The CSLFRF final rule allows governments receiving funds to allocate them to enhance existing infrastructure (storm and wastewater specifically) to address critical needs in their communities. Webb County has a significant portion of its population that do not have reliable sources for drinking water. A large portion of the projects within the program are designed to extend water lines and sewar lines to these areas, filling a critical need for an economically disadvantaged and underserved region. All ARPA projects adopted by Webb County that fit this eligible category and sub-category are listed below.

# Other ARPA Funds Received by Webb County

As previously reported, Webb County has received over \$6,000,000 from several other governmental programs related to pandemic recovery. These funds have directly supported county residents with rental, energy, and career assistance as they recover from the economic impacts of the pandemic. The funds received and their usages includes:

- Texas Department of Housing and Community Affairs CARES funds
  - o \$1,847,312 assisted 2,374 low-income households with 12 months of energy assistance.
- Texas Department of Housing and Community Affairs (TDHCA) Comprehensive Energy Assistance Program (CEAP) ARPA funds
  - o \$1,774,568 assisted 411 low-income households with 12 months of energy assistance.
- Texas Department of Housing and Community Affairs (TDHCA) CSBG CARES funds
  - o \$797,591 allowed 128 Webb County resident to attend Truck Driver Training as a means of transitioning out of poverty.
- Texas Department of Agriculture (TDA) TxCDBG Emergency Self-Help Center (E-SHC) funds
  - o \$267,000 assisted 166 households with food and care packages as well as \$700 gift cards for groceries.
- Department of U.S. Treasury Emergency Rental Assistance (ERA) Program
  - o \$850,000 assisted 58 households with up to 12 months and/or up to \$1,351 monthly rental assistance.
- Texas Department of Housing and Community Affairs (TDHCA) Texas Emergency Mortgage Assistance Program (TEMAP)
  - \$500,000 assisted approximately 60 households with up to 6 months and/or up to \$1,351 monthly mortgage assistance.
- Texas Department of Housing and Community Affairs (TDHCA) Community Resiliency Program (CRP)
  - Funds received enabled construction of a brand new 9,600 sq ft health center, providing the first of its kind for southern Webb County. The center will provide health care and public health services to low-to-moderate income residents of Rio Bravo, El Cenizo, and La Presa

# **Promoting Equitable Outcomes**

Webb County is committed to utilizing the funds received through ARPA to promote equitable outcomes for its residents. The county is using the funds received to target some of the most underserved areas of the county, like the projects in the Colonia La Presa area to ensure resident receive reliable potable water and sewage services. The county is also using the funds to address emergency response gaps for their rural residents through projects like the Southern Fire Station and county Emergency Operations Center, both of which will enable better emergency response efforts for rural county residents.



#### Goals

From the beginning of the program, Webb County Commissioners and personnel have stived to keep equitable outcomes for their residents and closing socioeconomic inequalities as a top priority for their APRA program. Through projects like the new facility for Community Action Agency and their Meals on Wheels program, the county strives to ensure residents in need can access and receive support services. Additionally, the funds have allowed the county to solve a major public health issue facing a significantly economically disadvantaged portion of their population by providing potable water and sewer infrastructure to residents of the Colonias area.

The Commissioner's Court will continue to keep the ARPA program goals at the forefront of all decisions for additional project spending and as current projects continue towards completion.

#### **Awareness**

Webb County posts all regular update reports provided by the project manager to the Commissioners Court website and the community is invited to attend Commissioners Court public meetings to hear the regular updates from the project manager. All ARPA program updates are captured in meeting agendas that are also posted publicly on the Commissioner's Court website in advance of every meeting. Additionally, the ARPA Review Committee has worked throughout the program to gather input from community members, government agencies, non-projects and other entities to ensure that funds are allocated where the need is greatest.

The Webb County ARPA program has also been highlighted in several local news stories that aim to raise awareness of the impact the federal funds have on county residents. Including a recent article in the Laredo Morning Times highlighting the Colonia La Presa Water Project.

#### **Access and Distribution**

Webb County continues to consider access to basic services and needs for its residents when allocating funds as part of the ARPA program. This includes reviewing applications submitted for project funding with the aim to provide the most benefit possible with the grants' funds. County personnel are always available to answer questions residents might have.

#### **Outcome**

The county's ARPA projects continue to provide direct positive outcomes to the population by improving critical infrastructure and working to ensure residents have access to clean water and effective sewage removal systems.

# **Community Engagement**

The Webb County Commissioner's Court receives regular updates in their public meetings



from the project manager. The Court meetings provide an opportunity for the public to speak on the proposed expenditures under the SLFRF funds. Additionally, Webb County will hold hearings to discuss newly proposed projects and allow the public to speak on their concerns or support of the proposed projects. Residents can contact the county Economic Development department with any questions or concerns on ARPA projects or how the funds are being allocated and spent, including in support of the community and underserved portions of the populations.

In 2024, Webb County Commissioners Court was held and will continue to hold public workshop at designated commissioners court meetings that are posted and publicly held to discuss possible uses for the remaining ARPA funds. The project manager continues to work with the Non-Governmental Organizations (NGOs) that received awards as part of the program to ensure their expenditures follow ARPA guidelines. The county continues to encourage and support community engagement for all its projects and services. All processes required for community engagement follow the guidance under the American Rescue Plan Final Rule and other guidance.

# **Labor Practices**

Webb County continues to use strong labor standard practices to promote effective and efficient delivery of all projects, while supporting economic recovery through strong employment opportunities for local workers. Webb County is committed to complying with all labor practice rules set out in the Final Rule including Davis-Bacon as applicable.

As various ARPA projects are released for bidding, the County takes steps to ensure minority and female owned business as well as labor surplus area firms are utilized as much as possible and requires all awarded contractors to follow the same procurement requirements when soliciting for subcontractors and suppliers. A list of all businesses and firms involved in ARPA projects is maintained by the project manager.

# **Use of Evidence**

Webb County will continue to identify if any program funds will be used for evidence-based interventions. Currently, there is one approved project that falls under evidence-based interventions for expenditure category, Public Health (EC1)- UV-C Lighting.

An independent study was provided to Webb County conducted by Innovative Bioanalysis to test the efficacy of the Light Progress UV Fan against aerosolized SARS-COV-2. Study results from the control runs were graphed and plotted to show natural viability loss over time in the chamber. The control data served as a basis to determine the reduction achieved with the Light Progress UV Fan device after a single air pass. When tested against SARS-CoV-2, the device was observed to have reduced the viral concentration from 6.32x10^6 TCID50/mL to an average of 1.51x10^3 TCID50/ml. Since the study had already been conducted, Webb County will not be identifying funds from the project budget for evidence-based interventions.

Webb County works diligently to ensure that all future ARPA projects are researched to



ensure compliance with the Use of Evidence requirement. Any new projects are reviewed prior to approval to verify applicability of the Use of Evidence requirement.

# **Performance Report**

Webb County Commissioners gather key performance data on the entire ARPA program through monthly project updates submitted by the project manager, and through periodic update presentations during Commissioner's Court meetings.

Rio Bravo Wastewater Treatment Plant Treatment Upgrades improvements are necessary to improve operations, ensure regulatory, compliance and meet future demand for capacity. The Webb County Regional WWTP was constructed around 2003-2004 and is a four (4) basin Sequencing Batch Reactor (SBR) that treats raw sewage from almost entirely residential sources. The plant is in poor mechanical and electrical condition. The SBRs and related equipment are unable to run with automatic controls. Average flows received by the plant are below the design flow for the plant. The SBR basin aeration and solids system all need heavy maintenance. Basins 1-3 require cleaning. The control system and many field devices are not functional. Since the initial plant construction, there have been no improvement expansions at the plant. The facility needs significant mechanical and electrical refurbishment to restore proper operation. After a full assessment of costs pertaining to the Headworks, it was recommended to replace to new than to rehabilitate due to the cost benefit and longevity of the improvement to increase functional capacity. The county included this to the overall project.

Currently, we are seeing that the Delta and Omicron variants have caused a sharp spike in cases despite vaccination efforts. This technology offers potential mitigation of the spread of Covid-19 and other viruses. As county employees we spend a large part of our days in our offices, many of those offices having high traffic from the general public. By installing these UV-C lights in our air duct systems we ensure that any bacteria, viruses and mold particulates passing through these ducts are eliminated from the air we are breathing. This project entails the purchase and installation UV-C Lighting within the air ducts of approximately 20 County buildings.

#### **Use of Evidence:**

An independent study provided to Webb County conducted by Innovative Bioanalysis to test the efficacy of the Light Progress UV Fan against aerosolized SARS-COV-2. Study results from the control runs were graphed and plotted to show natural viability loss over time in the chamber. The control data served as a basis to determine the reduction achieved with the Light Progress UV Fan device after a single air pass. When tested against SARS-CoV-2, the device was observed to have reduced the viral concentration from 6.32x10<sup>6</sup> TCID50/mL to an average of 1.51x10<sup>3</sup> TCID50/ml.

## **Performance Report:**

**Output:** Webb County is in the procurement process with advertising for an RFP to qualified interest parties to competitively bid for the purchase and installation of UV-C Lighting in County Essential Buildings.
