### GENERAL OVERVIEW

### **Executive Summary**

Due to the COVID-19 public health emergency, the Westmoreland County Board of Commissioners have methodically allocated millions of dollars in federal, state, and local assistance to small businesses, municipal governments, fire departments, and nonprofits within the county to mitigate the spread of COVID-19 and assist those who were negatively impacted by the pandemic.

The American Rescue Plan Act allocated a total of \$105.3 million in State and Local Fiscal Recovery Funds (SLFRF) to Westmoreland County. In May 2021, Westmoreland County received the first half of these funds in the amount of \$52.6 million with the second half received in July 2022. The Westmoreland County Board of Commissioners have judiciously reviewed the Interim Final Rule and have focused the last several months on methodically developing a spending plan for these funds. Several meetings were held to determine the greatest need for these funds, and those meetings will continue to take place until all SLFRF are allocated appropriately.


Through June 30, 2025, Westmoreland County has obligated the \$105.3 million, as required, and expended \$74.7 million of the SLFR funds. This includes, but is not limited to, a food insecurity program, a human services grant program, a vacant and abandoned building demolition and rehabilitation program, cyber security software, public safety communication equipment and administrative costs. # **Uses of Funds**

As indicated in the executive summary, from the time of award to June 30, 2025, \$74,691,129.48 of SLFR funds have been expensed and all funds were obligated as of December 31, 2024. A breakdown by expenditure category is as follows:

# **Public Health – EC1:**

An undetermined portion of the SLFRF will be allocated towards public health and COVID-19 pandemic response, including public safety communication equipment, personal protective equipment, and other public health expenses.

# **Negative Economic Impacts – EC 2:**

Westmoreland County is home to many high-performing provider agencies working tirelessly to meet the needs of the county's most vulnerable citizens. To meet the increasing demand for human services, the County Commissioners will consider increasing provider capacity to ensure they are fully equipped to meet the evolving complex needs of a growing number of vulnerable people. Those citizens, small businesses, and non-profits of the county who have experienced negative economic impact are in need of assistance in recovering from the COVID-19 pandemic. The effect of a shrinking budget is further exacerbated by the impact of the COVID-19 pandemic on service providers. An average of 87 percent of nonprofits experienced negative financial impact in contrast while 36 percent reported an increase in demand for services (The Pittsburgh Foundation; United Way of Southwestern Pennsylvania). A Negative Economic Impacts program currently under way is the Food Insecurity Program with the Westmoreland County Foodbank.

Housing and shelter services for individuals who are, or are at risk of becoming, homeless seem to be acutely low, possibly with fewer emergency beds and transitional housing options than any other county of our size and scope (The Pittsburgh Foundation). Officials from United Way of Southwestern Pennsylvania's 2-1-1 service noted that up to two-thirds of the 1,300 calls received by staff in January 2021 were related to housing or rental assistance. This conflict in increasing demand and inadequate levels of service as indicated by a provider survey, which was conducted in 2020, presents significant issues to the County's ability in being able to meet resident needs.<sup>2</sup> Funds from the American Rescue Plan Act's Emergency Rental Assistance Program (ERAP) are currently being used to address this growing concern.

# **Project: Food Insecurity Program**

The Westmoreland County Foodbank works diligently to support Westmoreland County families and individuals so that they do not need to make the difficult decision as to whether they must sacrifice food over other pressing needs. However, the onset of the COVID-19 pandemic in Southwestern Pennsylvania increased the demand for food from the Food Bank exponentially. \$4,471,500 of ARPA State and Local Fiscal Recovery Funds have been obligated to the Food Bank to address identified needs such as technology improvement to improve access and to better serve consumers in need, expansion of the Food Bank's current location to include a volunteer center and updated cooler, programmatic funding to End Hunger in Westmoreland County such as a Farmer's Truck to distribute fresh produce in areas of need throughout the County and support for the Summer Food Services Program (SFSP), which

provides meals where free and reduced lunches leave off at the school year's end. Through June 30, 2025, the Food Bank has received \$2,058,361.98 of funds and spent \$1,733,268.64 of these funds. Funds were budgeted as follows:

# Public Health - Negative Economic Impact: Public Sector Capacity - EC 3:

Another area that the Westmoreland County Commissioners will take into consideration is the negative economic impacts to the public sector capacity.

In October 2022, the Board of Commissioners approved an agreement in the amount of \$949,000 with the Westmoreland County Forum for Workforce Development (The Forum), a standing sub-committee of the Economic Growth Connection (EGC) of Westmoreland, for a Workforce Development program.

# **Project: Workforce Development**

Through this program, the ECG aims to develop and execute a comprehensive workforce development plan for the county, aimed at engaging our future workforce, helping to steer them towards careers that will positively impact Westmoreland County.

Regional Pathway System (\$250,000) - The Forum for Workforce development will create a regional pathway system to provide clarity and equity of experience to the students, parents and educators of Westmoreland County including Business & Finance, Information Technology, Engineering & Production, Health Sciences, and Construction.

Internships - An Internship Is defined as any official or formal program, or period, in which a

beginner acquires practical experience in an occupation, profession or pursuit. The internship program proposed to remedy the lack of local manufacturing/industrial internships in the region include:

- Create Internship Coordinator position to lead all aspects of growing and supporting all Internship-related processes with regional High Schools, Career and Technology Centers and Post-Secondary institutions.
- Create an internship model based on criteria gathered from established school guidelines and proven best practices based off, already established/successful, internship programs with local businesses.
- The Forum for Workforce Development has the infrastructure to be a primary resource for internship communications between affiliated businesses and schools via the Careerhub and will offer these services for businesses to advertise all open/available positions and students to use as a search element.
- To get the word out about the Importance and successes of Internships we plan to advertise to local businesses the Importance of Internships via marketing collateral and provide guidance through meetings and other means of communication.

Westmoreland County Forum for Workforce Development Leadership and Program Development Support Educational Leadership and Innovation Consultants - A group of Nationally Recognized School Leaders will work directly with Westmoreland County Forum for Workforce Development and School District Cabinet-Level leadership in developing Career and Life-Preparing programs. The program involves five distinct phases and an ongoing new leader support system:

Phase One- Input and Analysis (\$40,000)

Phase Two- Leadership Development and Visioning (\$51,000)

Phase Three- Leadership Mentoring (\$90,000)

Phase Four- District-Level Regional Leadership Retreats and Action Planning (\$45,000)

Phase Five- Progress Analysis, Course Adjustment, and Action Planning Summer Retreat (\$45,000)

Miscellaneous Expenses- (\$20,000)

Phase Six: Sustainability (\$105,500 per Year)

As of June 30, 2025, the Economic Growth Connection expended \$949,000 on the Westmoreland Workforce Development Plan.

# **Infrastructure – EC 5:**

Westmoreland County Commissioners have obligated a portion of the SLFRF funds towards regional broadband. A 2018 Comprehensive Plan listed broadband to be a key core objective in Westmoreland County. In this modern age, the internet is an increasingly integral part of nearly every aspect life<sup>1</sup>, particularly with the rise in remote work, learning, and healthcare. Per the Commonwealth: "High speed internet access is essential to growing our economy, expanding educational opportunities for our children, increasing access to modern healthcare, and improving the safety of our communities. [The goal is to] close the digital divide ensuring every citizen and business has the access it needs to connect to the ever-expanding digital world in which we live and work."

In May 2022, the Board of Commissioners approved a contract with Michael Baker International, Inc. to assist in the targeted expansion, construction, and deployment of broadband infrastructure and service in Westmoreland County. As of June 30, 2024, \$39,150 of SLFRF has been obligated and expensed towards this contract. A total of \$15 million has been set aside in the SLFRF plan towards Broadband expansion in the County. The remainder of these funds, however, are obligated in the Revenue Replacement expense category.

During the summer of 2022, Westmoreland County launched a collaborative research initiative aimed at analyzing the County's current broadband infrastructure to develop a comprehensive approach to aid in planning efforts for connecting residents and businesses with high-speed, affordable internet access. As part of this research, existing infrastructure was inventoried to establish the location of unserved locations and field crews distributed door hangers to homes and businesses inviting them to take part in a broadband survey and speed test.

In the Spring of 2023, Westmoreland County issued a Request for Proposals (RFP) to enter into an Agreement with the County for Early Action Projections for the Expansion of Broadband Utilities and Service. After the completion of Westmoreland Broadband's Data Collection and Feasibility Study, it was determined to move forward in four project areas for early action. The four Early Action areas of Fairfield Township, Derry/Gray Station Road, Derry Township, and Ligonier/Waterford. The purpose of the RFP was to assist in the targeted expansion, construction, and deployment of broadband infrastructure and service to areas of the County that do not have access to the internet, or whose connection is insufficient to carry out everyday tasks. Not only is the County interested in expanding the network to those in need, but it is also looking to address affordability to ensure that access can be achieved at a reasonable cost.

# **Intended Outcomes**

The County recognizes the importance that internet access plays in everyday life and the investment in the infrastructure needed to expand or enhance broadband connectivity in underserved areas. Aggressively expanding and enhancing the County's technology infrastructure will work to close the digital divide.<sup>1</sup>

In 2020, prior to the pandemic affecting Westmoreland County, a regional broadband study was conducted to determine where internet access expansion is necessary, particularly in many rural areas of the County creating a digital divide. The pandemic has made affordable, dependable internet access mission critical to daily life to allow County residents to safely attend school, work, appointments and activities, connect with friends and family, or access information from critical resources from the safety of their own home. The contract with Michael Baker International, Inc. will provide Westmoreland County with solutions to gain efficiencies in broadband program management, planning, mapping, and deployment.

### Goals

The strategy to expand broadband services throughout the county, with the largest focus being in rural areas of the county, would be to partner with municipalities, school districts, and other counties to expand broadband infrastructure. As with many other disparities, the pandemic emphasized an already uneven playing field and the goal is to bring those underserved communities up to the same level as those areas with strong connectivity.

# Revenue Replacement – EC 6

Revenue replacement, expenditure category 6, is being considered by the Westmoreland County Board of Commissioners to recover lost revenues due to the COVID-19 public health emergency and allocate those funds towards provision of government services. The calculation provided by the Treasury Final Rule will be used to determine the estimated amount of reduction in revenue annually. Using 2019 as the base year for general revenue, revenue loss calculations total a loss of over \$93.8 million.

**Project:** Vacant and Abandoned Building Demolition and Rehabilitation Program

**Funding Amount:** \$10,400,00.00

**Project Overview:** The Redevelopment Authority of the County of Westmoreland and Westmoreland County Land Bank (collectively referred to as RA/LB throughout) will carry out eligible activities related to Vacant and Abandoned Buildings according to the Final Rule on the use of ARPA SLFRF funds. In the case of Westmoreland County, these activities will be conducted within Qualified Census Tracts for 2022 as identified in HUD's 2021 and 2022 Small DDAs and QCTs map viewer here:

The project will generally follow discrete, yet overlapping phases, depending on the type of activity, whether demolition or rehabilitation.

**Demolition Activities Outputs**: Demolish roughly 320 vacant, abandoned, and blighted buildings out of a potential 511 properties.

**Demolition Activities Outcomes:** Strong relationships between the quality of one's neighborhood built environment have been established through the Center for Disease Control and Prevention's Social Determinants of Health<sup>1</sup>, and research into the effect of vacant lot greening on mental health<sup>2</sup>, and targeted, structural housing repairs on crime<sup>3</sup>. The RA/LB's efforts to remove vacant, abandoned, and dangerous buildings from Qualified Census Tracts will surely improve the quality of the built environment.

**Rehabilitation Activities Output:** Rehabilitate up to six multi-story, mixed-use, buildings to reposition them for private investment.

### **Rehabilitation Activities Phases:**

Phase I Activity Identification: To date, all seven communities which have Qualified Census Tracts have conducted comprehensive vacant, abandoned, blighted, and/or tax delinquent property inventories. From this list, municipal officials identified larger, multi-story, mixed-use buildings that have value for redevelopment purposes. Phase II Activity Assessment and Clearance: All potential rehabilitation activities will undergo a multifaceted assessment of a building's value for reuse, feasibility, financial analysis, market analysis, alternatives analysis, return on investment analysis, and historical/architectural value analysis. Activities which rank highly will be selected to move on to the next phase.

Phase III Activity Acquisition: Properties selected in the previous round will be acquired through various means including:

- donation by owner
- delinquent property tax sales by the Land Bank
- market purchase
- Conservatorship pursuant to Pennsylvania Act of Nov. 26, 2008, P.L. 1672, No. 135 Phase IV Construction: Construction scopes, timelines, and funding sources will be designed. Bid packages will be developed and awarded to the lowest responsible bidder. Phase III Activity Closeout: All bid documents, contracts, photographs, and other documentation will be organized and housed for reporting purposes.

# **Progress Report:**

As of June 30, 2025, there are 43 projects under contract, and 251 projects that are complete. A total of \$5,191,841.91 has been spent cumulative to date. A total of \$826,097.55 has been committed but not yet expended. The RACW has received \$6,700,243 million of their \$10.4 million obligation.

# **Project: Municipal Water and Sewage Program**

\$10 million in funding was allocated towards a municipal water and sewer program for publicly owned water and sewer systems in Westmoreland County. Critical water and sewer projects were prioritized based on those that have a positive and substantial impact on affordable housing, economic recovery, and public health. Awards for the Municipal Water and Sewage Program were announced at the June 22, 2023 Commissioners' Public Meeting:

# Project: NKAMP, LLC.

An agreement with the New Kensington Advanced Manufacturing Park (NKAMP) was approved on the May 11, 2023 Commissioners' Public Meeting. This agreement, for \$1 million, will invest in the development and modernization of the project to transform a nearly 70-acre property in the Alle-Kiske Valley area to establish a 175,000-square-foot manufacturing operation in the park.

# **Promoting Equitable Outcomes**

Westmoreland County Commissioners recognize the unique identities, backgrounds, and cultures of the residents of the County. At this time, the County does not have projects in this category but will determine workforce practices on infrastructure projects being pursued (EC 5) using strong labor standards to promote effective and efficient delivery of high quality infrastructure projects while also supporting the economic recovery through strong employment opportunities for workers.

Additional labor standards will be implemented at the discretion of the Westmoreland County Board of Commissioners.
