### April Release 04.1.2024

---

- Both the Official and Unofficial Notice/Declaration export buttons now create Word documents instead of PDFs.

### November Release 11.21.2022

---

- Users have the ability to add footnotes.

### October Release 10.24.2022

---

- The “Generate Document” button on the Submission Review page is re-labeled to “Generate Document: Official Format”.
  - Upon portal registration, users receive a welcome email that includes an email contact for support questions as well the user guide.

### September Release 09.26.2022

---

- Users may now create a “Company Profile” which saves information regarding an acquirer that can be auto filled into a newly created filing. Please see our user guide for more details.
  - Users can now provide access to a restricted document on a question set to other users.

### August Release 08.29.2022

---

- Question Sets have been reformatted to display all questions and answers on a single page and to allow for the attachments of all documents in one place.
  - Users can now provide access to a restricted document on a question set to other users.
  - Users can add other users to question sets.
  - Filing downloads now have the case name in the file name.

### July Release 07.25.2022

---

- Expanded the number of questions sets displayed at a time from 4 to 10.
  - Modified the Filing Fee column on the All Filings page to display filing fee status rather than amount.

06.27.2022

- Cases that have been closed for 30 days or more will no longer display.
  - Question sets related to cases 30 days or older will no longer display.
  - Users can now paste the maximum number of characters in text boxes.
  - Corrected character count to display at 0 in blank text boxes.
  - Corrected the initial participant name to display without the filing name.

  - Modified open text boxes to rich text for all filing types.
  - Updated functionality of the Save & Next button on the Submission Review tab to redirect to the Payment tab once clicked.

  - Fixed functionality for the View Details button on the Primary Contacts sub grid.
