⁴ The Net Allocations Available are the net amounts remaining after obligations issued by Treasury under the Direct Component and Centers of Excellence Research Grants program and obligations by or transfers to the Council and NOAA out of their Trust Fund allocations based on their requests.

⁵ These totals do not include the Fiscal Year 2019 earned interest on the trust fund. The RESTORE Act requires that Treasury allocate the prior fiscal year's earned interest to the Comprehensive Plan (50%), NOAA's Science Program (25%), and Centers of Excellence Research Grants Program (25%). Under the Final Rule, Treasury shall allocate the funds within 10 days after the federal fiscal year end.
